HISTORIC PRESERVATION: Commemorates the listing by the United States Department of the Interior of the Caddo Parish Confederate Monument on the National Register of Historic Places on January 29, 2014

A RESOLUTION

2	To commemorate the official listing by the United States Department of the Interior of the
3	Caddo Parish Confederate Monument on the National Register of Historic Places.
4	WHEREAS, the National Register of Historic Places is the official list of the Nation's
5	historic places worthy of preservation, and, as authorized by the National Historic
6	Preservation Act of 1966, the National Park Service's National Register of Historic Places
7	is part of a national program to coordinate and support public and private efforts to identify,
8	evaluate, and protect America's historic and archeological resources; and
9	WHEREAS, the commitment of the parish of Caddo to the preservation of its history
10	and obtaining the listing of the Caddo Parish Confederate Monument on the National
11	Register on January 29, 2014, reflects the community's desire to build and grow from a base
12	of understanding its own past; and
13	WHEREAS, the Caddo Parish Confederate Monument is of statewide significance
14	as one of four major Louisiana monuments representing what is known by historians as "the
15	Cult of the Lost Cause," representing the Memorial Period of the Civil War Commemorative
16	Sculpture Movement, and reflecting the introduction and presence of Civil War monument
17	construction in Louisiana and the role women played in the memorial period; and
18	WHEREAS, all those who played a role in creating and preserving this monument
19	exemplifying art as history deserve recognition for their contribution to the community and
20	to history.

- 1 THEREFORE, BE IT RESOLVED that the House of Representatives of the
- 2 Legislature of Louisiana does hereby commemorate the official listing on January 29, 2014,
- 3 by the United States Department of the Interior of the Caddo Parish Confederate Monument
- 4 on the National Register of Historic Places.
