A RESOLUTION

2	To commend Disabled American Veterans Department of Louisiana, upon the occasion of
3	its ninety-second annual state convention and recognize the admirable, tireless work
4	the organization does for disabled veterans and their families throughout our state
5	and nation.
6	WHEREAS, Disabled American Veterans (DAV) was founded in 1920 to fulfill our
7	country's promise to those who served; and
8	WHEREAS, Disabled American Veterans Department of Louisiana, was established
9	in Louisiana in 1922, is headquartered in Baton Rouge, and is made up of seventeen chapters
10	throughout the state; and
11	WHEREAS, DAV is a unique organization of disabled veterans helping disabled
12	veterans; and
13	WHEREAS, DAV Central Louisiana Chapter 7 was established in 1959 to serve the
14	Pineville and Alexandria areas; and
15	WHEREAS, the name of DAV Central Louisiana Chapter 7 was changed in 2007
16	to Paul P. Benoit Memorial Chapter 7, after an esteemed physician's assistant who worked
17	at the Alexandria Veterans Association Medical Center and who was the driving force
18	behind the local chapter's success over ten years; and
19	WHEREAS, currently composed of seven hundred twenty-nine members, the Paul
20	P. Benoit Memorial Chapter 7 is tirelessly involved in the community by coordinating
21	projects that make a difference in the lives of veterans such as having wheelchairs repaired,

1	by brightening Christmas for those in the hospital and veterans homes by giving each hero
2	a Christmas card with a five dollar bill inside, and by ringing the Salvation Army bell for
3	donations for those in need; and
4	WHEREAS, in addition to caring, personal outreach, DAV, Department of
5	Louisiana, helps financially support Louisiana veterans homes and donates its labor and
6	resources to provide flags and wreaths for two veterans' cemeteries, Alexandria National
7	Cemetery in Pineville and the newly opened Central Louisiana Veterans Cemetery in
8	Leesville; and
9	WHEREAS, composed of one million two hundred thousand members nationwide,
10	DAV empowers veterans to lead full, high-quality lives with respect and dignity by ensuring
11	that veterans and their families can access the full range of benefits available to them; and
12	WHEREAS, DAV fights for the interests of our nation's injured heroes and works
13	to educate the public about the incredible sacrifices our veterans have made for the United
14	States; and
15	WHEREAS, DAV provides free, professional assistance to veterans and their
16	families in obtaining benefits earned through military service while caring for the
17	complicated needs of those American heroes who are transitioning back to civilian life; and
18	WHEREAS, DAV is politically active, representing the interests of disabled
19	veterans, their families, their widowed spouses, and their orphans; and
20	WHEREAS, DAV provides a structure through which disabled veterans can express
21	compassion for their fellow veterans through a variety of volunteer and outreach programs,
22	which creates a community of belonging and comraderie through common experiences; and
23	WHEREAS, the national DAV organization, as well as the state department and local
24	chapters, are supported by membership dues, through fundraising events, and through the
25	generous support of ordinary Americans throughout the nation who recognize the
26	importance of their mission; and
27	WHEREAS, DAV is an invaluable and vital organization dedicated to aiding
28	American heroes for their noble and admirable service to the United States of America.
29	THEREFORE, BE IT RESOLVED that the House of Representatives of the
30	Legislature of Louisiana does hereby commend Disabled American Veterans, Department
