AN ACT

2 To appropriate funds out of the General Fund of the state of Louisiana for Fiscal Year 2015-3 2016 to be used to pay the judgment in the suit entitled "Murphy Cormier General 4 Contractor, Inc. v. State of Louisiana, Department of Health and Hospitals, et al"; to 5 provide for interest; to provide for costs and attorney fees; and to provide for related 6 matters. 7 Be it enacted by the Legislature of Louisiana: 8 Section 1. The sum of Seven Million Four Hundred Twelve Thousand Three 9 Hundred Eighty-Three and No/100 (\$7,412,383.00) Dollars, plus legal interest from July 10 19, 2007, until paid, plus costs in the amount of One Hundred Ten Thousand Five Hundred 11 Seventy-Eight and 31/100 (\$110,578.31) Dollars, plus legal interest from December 20, 12 2011, until paid, plus Third Circuit Court of Appeal costs in the amount of Sixty-Six 13 Thousand Three Hundred Sixty-Two and 45/100 (\$66,362.45) Dollars, are hereby 14 appropriated out of the General Fund of the state of Louisiana for Fiscal Year 2015-2016 to 15 be used to pay the judgment in the suit entitled "Murphy Cormier General Contractor, Inc. 16 v. State of Louisiana, Department of Health and Hospitals, et al", bearing Number 2007-17 3828, Division "H", on the docket of the Fourteenth Judicial District Court, parish of 18 Calcasieu, state of Louisiana; No. 12-1000 on the docket of the Third Circuit Court of 19 Appeal, state of Louisiana; and No. 2013-C-1491 on the docket of the Supreme Court of the

- 1 Section 2. The judgment provided for in Section 1 hereof shall be deemed to have
- 2 been paid on the effective date of this Act and legal interest shall cease to run as of that date.
- 3 Section 3. This Act shall become effective on July 1, 2015; if vetoed by the governor
- 4 and subsequently approved by the legislature, this Act shall become effective on July 1,
- 5 2015, or on the day following such approval by the legislature, whichever is later.
