2	To commend Viona Lapeyrouse Chabert on the occasion of her eightieth birthday.
3	WHEREAS, Viona Lapeyrouse Chabert, the daughter of Abby and Florence
4	Lapeyrouse of Chauvin, was born April 23, 1935; and
5	WHEREAS, Miss Viona was the oldest of five children: Ouida, Una, Lloyd, and
6	Tillman; and
7	WHEREAS, the Lapeyrouse family lived on Bayou Lil Caillou and that is where they
8	made their living by trapping and shrimping, with Abby also working to make ends meet as
9	a janitor and at a small gas station that he owned; and
10	WHEREAS, after his distinguished service in the United States Army during the
11	Korean Conflict, the late Senator Leonard J. Chabert of Cut-Off met and later married
12	Viona, on May 10, 1953; and
13	WHEREAS, together she and Leonard settled down in Chauvin and raised their five
14	children: Donna Chabert Malbrough, former Senator Marty J. Chabert, Lori Chabert
15	Blanchard, Lenny Chabert, and Senator Norby Chabert - who claims to be her favorite; and
16	WHEREAS, Miss Viona supported Leonard in his efforts to attain his graduate
17	equivalency diploma and a degree in education from Nicholls State University on the G.I.
18	Bill; and

1	WHEREAS, the old saying, "Behind every great man is a great woman" certainly
2	applies to Miss Viona who, as a mother and homemaker, allowed Leonard to pursue his
3	political and business ventures; and
4	WHEREAS, while she was hesitant about Leonard entering the field of politics, she
5	was his biggest supporter during his public service as justice of the peace, school board
6	member, two-term state representative, three-term state senator, and President Pro-Tempore
7	of the Louisiana Senate; and
8	WHEREAS, upon Leonard's founding of a state charity hospital in Houma, the South
9	Louisiana Medical Center, Viona gave her time as a volunteer managing the hospital gift
10	shop; and
11	WHEREAS, after Leonard's untimely death in 1991, Miss Viona assumed leadership
12	of the Chabert family with reluctant dignity and grace; and
13	WHEREAS, one of her proudest moments came on the first day of Marty's term in
14	the state senate, when the legislature changed the name of the South Louisiana Medical
15	Center to the Leonard J. Chabert Medical Center; and
16	WHEREAS, to this day Miss Viona believes in the mission of the Leonard J. Chabert
17	Medical Center to serve the poor and the uninsured people of the bayou region that find
18	themselves in the same position as she and Leonard did growing up and in the early days of
19	their marriage; and
20	WHEREAS, Miss Viona is the proud grandmother of sixteen, prouder
21	great-grandmother of thirteen, and excited to welcome as many more as the good Lord will
22	bless her with; and
23	WHEREAS, as the matriarch of the Chabert family, she is beloved, respected, and
24	known up and down the bayou as "Lady Vi"; and
25	WHEREAS, she is the only lady in Louisiana history to have been married to a state
26	senator and mother to two state senators; and
27	WHEREAS, Miss Viona is a fine Christian woman and a true Louisiana lady in every
28	sense of the phrase.
29	THEREFORE, BE IT RESOLVED that the Senate of the Legislature of Louisiana
30	does hereby commend Viona Lapeyrouse Chabert on the occasion of her eightieth birthday.
