PESTICIDES/HERBICIDES: Provides with respect to the use of pest control products in certain school classrooms

2	To amend and reenact R.S. 3:3382(3) and 3386(A), relative to the use of pesticides in certain
3	school classrooms; to provide for the use of pesticides in pre-kindergarten; to
4	provide for a definition; and to provide for related matters.
5	Be it enacted by the Legislature of Louisiana:
6	Section 1. R.S. 3:3382(3) and 3386(A) are hereby amended and reenacted to read
7	as follows:
8	§3382. Definitions
9	As used in this Part, the following terms shall have the following meanings
10	ascribed to them:

12	(3) "School" means any public or private day or residential school that
13	provides pre-kindergarten, elementary, or secondary education.

15	§3386. Application of pesticides by certified commercial applicator
16	A. No person shall apply or supervise the application of any herbicide,
17	rodenticide, insecticide, or restricted use pesticide, on a non-fee basis for grass and
18	weed control, and rodent and general pest control in, on, or around structures or
19	grounds of schools that provide education to kindergarten pre-kindergarten through
20	twelfth grade classes, unless that person is a certified commercial applicator or is

under the supervision of a certified commercial applicator as provided in R.S. 3:3242
and the rules and regulations adopted thereunder. Such certified commercial
applicator shall be trained in integrated pest management that includes but is not
limited to pest prevention, least toxic methods of pest control, and applying
pesticides judiciously. Training material shall include but not be limited to the
guidelines in the EPA publication "Pest Control in the School Environment:
Adopting Integrated Pest Management".

Abstract: Regulates the use of pest control products and product application in prekindergarten schools. Modifies the definition of "school".

<u>Present law</u> defines "school" as any public or private day or residential school that provides elementary or secondary education. <u>Proposed law</u> modifies <u>present law</u> by adding pre-kindergarten to the definition.

<u>Present law</u> prohibits the application of any herbicide, rodenticide, insecticide, or restricted use pesticide, on a non-fee basis for grass and weed control, rodent and general pest control in, on, or around structures or grounds of any school that provides education to kindergarten through 12th grade classes, unless that person is a certified commercial applicator or is under the supervision of a certified applicator as provided for in proposed law. Proposed law modifies present law by adding pre-kindergarten, thereby requiring a certified commercial applicator or a person under the supervision of a certified applicator to apply any herbicide, rodenticide, insecticide, or restricted use pesticide in, on, or around structures or grounds of pre-kindergarten schools.
