 - (1) Regular mail via the United States Postal Service.
- (2) Certified mail via the United States Postal Service. 32
- (3) A commercial mail delivery service other than the United States Postal 33

- 35 C. In addition to facilitating provision of reports to patients in accordance 36 with Subsection A of this Section, a healthcare facility may provide such reports 37 electronically through an electronic patient portal that meets applicable standards 38 provided in federal law and regulation."
