Authorizes the governing authority of Calcasieu Parish to use a portion of the monies allocated from the Parish Transportation Fund to perform additional work within Calcasieu Parish. (8/1/15)

Proposed law authorizes the governing authority of Calcasieu Parish to use a portion of the monies allocated from the Parish Transportation Fund to perform additional work to include: landscaping and maintenance improvements along interstate highway right-of-way within Calcasieu Parish, and capacity improvements to state highways in Calcasieu Parish in accordance with DOTD standards. Proposed law provides that the additional work shall be performed provided that the project cost does not exceed the contract limit as defined by law and provided that the Calcasieu Parish governing authority indemnifies the state for any loss or injury arising therefrom. Proposed law is effective August 1, 2015.
