13 oriented criminal offense that occurred on or after January 13, 2015, in accordance with  
14 emergency rules promulgated by the Crime Victims Reparations Board and pursuant to  
15 Executive Order BJ 14-17, which provides relative to the administrative rules, policies, and  
16 practices for medical expenses and examinations related to victims of a sexually-oriented  
17 criminal offense."
