7	Section 1. The introductory paragraph of R.S. 13:5554(G)(3) and (3)(b) are hereby

13	(3) Notwithstanding the provisions of Subsection D of this Section, in the
14	parish of West Baton Rouge, one hundred percent of the premium costs of group

paid in full from the sheriff's general fund for any sheriff and full-time deputy sheriff

<u>Present law</u> provides for payment of premium costs of group hospital, surgical, medical expense, vision and dental insurance, and life insurance by the West Baton Rouge Parish Sheriff's Office for sheriffs and employees who retire from the West Baton Rouge Parish Sheriff's Office.

<u>Proposed law</u> retains <u>present law</u> payment provisions providing that 100% of the premium costs of group hospital, surgical, medical expense, vision and dental insurance, and life insurance will be paid by the West Baton Rouge Parish Sheriff's Office for all sheriffs and employees who were hired prior to June 30, 2008, and retire with 12 years of service with the West Baton Rouge Parish Sheriff's Office and who are at least 55 years of age.

<u>Proposed law</u> changes the payment provisions <u>from</u> 30 years or more of service with the West Baton Rouge Parish Sheriff's Office <u>to</u> 30 years or more of service credit with the Sheriffs' Pension and Relief Fund, regardless of age for 100% of the premium costs of group hospital, surgical, medical expense, vision and dental insurance, and life insurance be paid by the West Baton Rouge Parish Sheriff's Office.
