(Constitutional Amendment) Requires the registrar of voters in each parish to be appointed for a term and authorizes the manner of appointment of the registrar to be provided by law

Proposed constitutional amendment provides that Registrars of Voters be appointed for a term concurrent with the term of the members of of the parish governing authorities. Proposed constitutional amendment also authorizes manner of appointment of the Registrars to be provided by law.

The proposed constitutional amendment will be submitted to voters at the statewide election on October 24, 2015.

Proposed constitutional amendment is a companion bill for HB 452, which provides the manner of appointment for Registrars of Voters by parish governing authorities and that employees of the Registrars of Voters cannot receive pay raises under certain circumstances.

EXPENDITURE EXPLANATION

There is no anticipated direct material effect on governmental expenditures as a result of the proposed constitutional amendment. The proposed constitutional amendment provides term lengths for Registrars of Voters, as well as appointment procedures for Registrars of Voters.

This bill will add a constitutional amendment to be considered by voters at the statewide election held on October 24, 2015. The Secretary of State may incur minimal ballot printing costs associated with this measure. As a regular practice, the Secretary of State typically budgets for up to 10 constitutional amendments and statewide propositions for the fall statewide elections. To the extent the ballot includes more than 10 constitutional amendments and statewide propositions, the Secretary of State may require additional resources for the October 24, 2015 statewide election.

A companion bill, HB 452, outlines provisions by which parish governing authorities must abide by when appointing Registrars of Voters.

REVENUE EXPLANATION

There is no anticipated direct material effect on governmental revenues as a result of this measure.
