WHEREAS, among her other accomplishments, Ms. Nolan serves as president and CEO for Health Agents for America, Incorporated, an association that represents agents and brokers exclusively; currently, HAFA represents agents in twenty-six states; Ms. Nolan is the field organizer for Medicare Today and has participated in a grassroots effort to introduce, enroll, and educate seniors about Medicare Part D; and
