11 AMENDMENT NO. 5

12 On page 1, line 10, after "reenacted" delete the comma "," and delete "R.S. 3:2058(K) is  
13 hereby enacted"

14 AMENDMENT NO. 6

15 On page 2, delete lines 15 and 16 in their entirety, and insert the following:

16 "(3)(a) Members shall serve as follows:  
17 (i) One member from the Louisiana Cattleman's Association and one member  
18 from the Louisiana Farm Bureau shall each serve one-year terms.  
19 (ii) One member from the Louisiana Cattleman's Association, one member  
20 from the Louisiana Farm Bureau, and one member from the Louisiana Livestock  
21 Auction Markets Association shall each serve two-year terms.  
22 (iii) One member from the Louisiana Cattleman's Association, one member  
23 from the Louisiana Farm Bureau, one member from the Louisiana Livestock Auction  
24 Markets Association, and one member from the Cattle Producers of Louisiana shall  
25 each serve three-year terms.  
26 (b) Thereafter, all appointments shall be for three-year terms. No appointee  
27 shall serve more than two consecutive three-year terms on the council. The initial  
28 appointments shall commence on August 17, 2016."
