FISHING/OYSTERS RE +\$403,394 SD RV See Note
Increases lease rental rates and severance taxes on oysters

Current law requires the Wildlife and Fisheries Commission to fix rental rates for oyster leases at \$2 per acre per year and deposits the revenue into the Conservation Fund.

Proposed law will set the rental rate for oyster leases at \$3 per acre per year beginning 1/1/2016 and will deposit revenue into the Public Oyster Seed Ground Development Account.

EXPENDITURE EXPLANATION

There are no anticipated expenditure increases as a result of proposed law.

REVENUE EXPLANATION

The proposed legislation is anticipated to result in a net increase in overall revenue collections in the amount of approximately \$403,000 annually due to an increase in the rental rates. In addition, the proposed legislation will place revenues from the lease rental payments into the Public Oyster Seed Ground Development Account within the Conservation Fund as opposed to flowing into the Conservation Fund at large. This bill increases the oyster lease rental rate from \$2 per acre per year to \$3 per acre per year beginning 1/1/2016.
