1 AMENDMENT NO. 1

2 On page 1, line 2, after "R.S. 4:176(B)" delete the remainder of the line and insert a comma
3 "," and insert "R.S. 27:15(B)(8), and R.S. 46:1816(C) and to enact R.S. 4:176(C) and R.S.
4 27:24(A)(6), 94, 252, and"

5 AMENDMENT NO. 2

6 On page 1, line 12, after "reenacted" insert "and R.S. 4:176(C) is hereby enacted"

7 AMENDMENT NO. 3

8 On page 2, between lines 14 and 15, insert:

9 "C. The Louisiana Racing Commission shall promulgate rules and
10 regulations as necessary and in accordance with the Administrative
11 Procedure Act for the administration and enforcement of this Section."

12 AMENDMENT NO. 4

13 On page 2, delete line 15, and insert:

14 "Section 2. R.S. 27:15(B)(8) is hereby amended and reenacted and R.S.
15 27:24(A)(6), 94, 252, and 394 are hereby enacted to read as follows:

16 §15. Board's authority; responsibilities

17 * * *

18 B. The board shall:

19 * * *

20 (8)(a) Adopt such policies and rules as are necessary to the efficient,
21 efficacious, and thorough conduct of the business of regulating and
22 controlling the gaming operations and activities under its jurisdiction and as
23 are required by this Title. Rules shall be adopted pursuant to the
24 Administrative Procedure Act and, notwithstanding any other provision of
25 law to the contrary, rules of the board shall be subject to legislative oversight
26 and review. The legislative review of the rules shall be conducted by the
27 legislative committees with jurisdiction over gaming and criminal matters as
28 provided by legislative rule.

29 (b) Promulgate rules and regulations in accordance with the
30 Administrative Procedure Act as necessary for the administration and
31 enforcement of R.S. 27:94, 252, and 394.

33 §24. Rulemaking authority; fees and fines, collection

34 A. The board, in accordance with the Administrative Procedure Act
35 and R.S. 27:15(B)(8), shall promulgate all rules and regulations necessary to
36 carry out the provisions of this Title, including but not limited to the
37 following:

39 (6) The administration and enforcement of accumulating unclaimed
40 monies on which the time period for collection has expired, the remittance
41 thereof to the state treasurer, and related matters as required by R.S. 27:94,
42 252 and 394.
