Amendments proposed by Representative Havard to Original House Bill No. 562 by Representative Havard

1 AMENDMENT NO. 1

2 On page 1, line 2, delete "To enact R.S. 39:24(G), 34(B)(3), and 54(B)(2)(d)," and insert "To
3 amend and reenact R.S. 39:34(A) and 38(A) and to enact R.S. 39:24(G),"

4 AMENDMENT NO. 2

5 On page 1, at the beginning of line 5, change "as nonrecurring;" to "as restricted;"

6 AMENDMENT NO. 3

7 On page 1, at the end of line 5, change "nonrecurring;" to "restricted;"

8 AMENDMENT NO. 4

9 On page 1, line 8, delete "R.S. 39:24(G), 34(B)(3), and 54(B)(2)(d) are" and insert "R.S.
10 39:34(A) and 38(A) are hereby amended and reenacted and R.S. 39:24(G) is"

11 AMENDMENT NO. 5

12 On page 1, delete lines 14 through 16 and insert the following:

13 "(2) If the forecast price per barrel"

14 AMENDMENT NO. 6

15 On page 2, line 1, after "and" and before "shall" insert a comma "," and "in addition to
16 designating such revenue as recurring or nonrecurring,

17 AMENDMENT NO. 7

18 On page 2, line 2, change "nonrecurring." to "restricted."

19 AMENDMENT NO. 8

20 On page 2, delete lines 11 through 29 and on page 3, delete lines 1 through 11 and insert the
21 following:

22 "A. The governor shall cause to be prepared an executive budget presenting
23 a complete financial and programmatic plan for the ensuing fiscal year which shall
24 include recommendations for appropriations from the state general fund and
25 dedicated funds which shall not exceed the official forecast of the Revenue
26 Estimating Conference. Except as provided by R.S. 39:75(E), the executive budget
27 shall not include recommendations for appropriations from any fund in excess of the
28 official forecast of money available for appropriation from that fund. The executive
29 budget shall not include recommendations for appropriations from the state general

1 fund from the portion of the state general fund designated as restricted pursuant to
2 R.S. 39:24(G).

4 §38. Additional proposals

5 A.(1) Any proposals by the governor to enhance revenues for the ensuing
6 fiscal year beyond the official forecast shall be itemized and projected separately and
7 shall constitute a submission by the governor separate and apart from the
8 recommendations in the executive budget based on the official forecast as provided
9 in Article VII, Section 11(A) of the Constitution of Louisiana and under the
10 provisions of this Chapter. Any such submission shall include a description of the
11 proposed uses and programmatic impacts of the enhanced revenues.

12 (2) Any proposals by the governor to appropriate revenues designated as
13 restricted pursuant to R.S. 39:24(G) shall be itemized and projected separately and
14 shall constitute a submission by the governor separate and apart from the
15 recommendations in the executive budget under the provisions of this Chapter. Any
16 such submission shall include a description of the proposed uses and programmatic
17 impacts of the restricted revenues.
