Amendments proposed by Representative Harrison to Engrossed Senate Bill No. 278 by Senator Brown

1 AMENDMENT NO. 1

2 On page 1, line 2, after "R.S. 33:4570.15" and before the comma "," insert "and 4570.16"

3 AMENDMENT NO. 2

4 On page 1, line 5, after "authority;" and before "and to" insert "to provide for a contingent
5 effective date;"

6 AMENDMENT NO. 3

7 On page 3, delete line 8 in its entirety and insert the following:

8 "Section 2. R.S. 33:4570.16 is hereby enacted to read as follows:

10 §4570.16 Creation of the North Lafourche Recreation Enhancement District;
11 election; ballot language

12 A.(1) At the statewide general election occurring on November 8,
13 2016, a proposition shall appear on the ballot in the parish of Lafourche to
14 determine whether the North Lafourche Recreation Enhancement District
15 shall be created.

16 (2) The ballot for the election shall state as follows:

17 "PROPOSITION TO CREATE THE NORTH LAFOURCHE RECREATION
18 ENHANCEMENT DISTRICT

19 Shall the North Lafourche Recreation Enhancement District be
20 created in the parish of Lafourche in the state of Louisiana?"

21 B.(1) If a majority of the qualified electors of the election area voting
22 on the proposition approve the proposition, then the North Lafourche
23 Recreation Enhancement District shall be created subject to the provisions
24 of R.S. 33:4570.15.

25 (2) If a majority of the qualified electors of the election area voting
26 on the proposition vote against such proposition, then the North Lafourche
27 Recreation Enhancement District shall not be created.

28 C. The secretary of state shall prepare the ballot for the election.

29 D. Except as otherwise provided, the election required pursuant to
30 this Section shall be conducted in accordance with the Louisiana Election
31 Code.

1 E. Notwithstanding Chapter 8-A of the Louisiana Election Code, the
2 costs of the election required pursuant to this Section shall be borne by the
3 state.

4 Section 3. Section 2 of this Act shall become effective on August 1,
5 2015.

6 Section 4. Section 1 of this Act shall become effective January 1,
7 2016 if the majority of the qualified electors of the election area voting on
8 the proposition approve the proposition to create the North Lafourche
9 Recreation Enhancement District.

10 Section 5. Section 1 of this Act shall be null, void, and of no effect
11 if the majority of the qualified electors of the election area voting on the
12 proposition reject the proposition to create the North Lafourche Recreation
13 Enhancement District."
