39 (d) The term "lease or rental", as herein defined, shall not mean the lease or
 40 rental of airplanes or airplane equipment by a commuter airline domiciled in
 41 Louisiana.

42 (e) For purposes of state and political subdivision sales and use tax, the term
 43 "lease or rental", as herein defined, shall not mean the lease or rental of items,

1 including but not limited to supplies and equipment, which are reasonably necessary
 2 for the operation of free hospitals.

3 (f) For purposes of "lease or rental" shall not mean the lease or rental of
 4 educational materials or equipment used for classroom instruction by approved
 5 nonprofit parochial and private elementary and secondary schools which comply
 6 with the court order from the Dodd Brumfield decision and Section 501(c)(3) of the
 7 Internal Revenue Code, limited to books, workbooks, computers, computer software,
 8 films, videos, and audio tapes.

9 (g)~~[RESERVED] For purposes of state and political subdivision sales and use~~
 10 ~~tax, "lease or rental" shall not mean the lease or rental of tangible personal property~~
 11 ~~to Boys State of Louisiana, Inc. and Girls State of Louisiana, Inc. which is used by~~
 12 ~~such organizations for their educational and public service programs for youth.~~

13 (h) For purposes of state and political subdivision sales and use tax, the term
 14 "lease or rental" shall not mean or include the lease or rental of motor vehicles by
 15 licensed motor vehicle dealers, as defined in R.S. 32:1252(14), or vehicle
 16 manufacturers, as defined in R.S. 32:1252(11), for their use in furnishing such leased
 17 or rented motor vehicles to their customers in performance of their obligations under
 18 warranty agreements associated with the purchase of a motor vehicle or when the
 19 applicable warranty has lapsed and the leased or rented motor vehicle is provided to
 20 the customer at no charge.

21 (i) For purposes of sales and use taxes levied and imposed by local
 22 governmental subdivisions, school boards, and other political subdivisions whose
 23 boundaries are not coterminous with those of the state, "lease or rental" by a person
 24 shall not mean or include the lease or rental of tangible personal property if such
 25 lease or rental is made under the provisions of Medicare.

26 (j) Solely for purposes of the sales and use tax levied by the state ~~or any~~
 27 ~~political subdivision whose boundaries are coterminous with those of the state,~~
 28 through March 30, 2016, the term "lease or rental" shall not include the lease or
 29 rental in this state of manufacturing machinery and equipment used or consumed in
 30 this state to manufacture, produce, or extract unblended biodiesel."

6 vehicle is purchased for commercial use, unless the vehicle purchased for
7 commercial use is assigned, garaged, and used outside of such political subdivision,
8 in which case the sale shall be deemed a "retail sale" or a "sale at retail" in the
9 political subdivision where the vehicle is assigned, garaged, and used."

26 capacity of eight persons, if, after all transportation, including transportation by the
27 purchaser, has been completed, the aircraft is ultimately received by the purchaser
28 outside of Louisiana. The place at which the aircraft is ultimately received shall be
29 considered as the place at which the aircraft is stored after all transportation has been
30 completed.

31 (n) For purposes of sales and use taxes imposed or levied by ~~the state or any~~
32 political subdivision thereof, the term "sale at retail" shall not include the sales of
33 pelletized paper waste when purchased for use as combustible fuel by an electric
34 utility or in an industrial manufacturing, processing, compounding, reuse, or
35 production process, including the generation of electricity or process steam, at a
36 fixed location in this state. However, such sale shall not be excluded unless the
37 purchaser has signed a certificate stating that the fuel purchased is for the exclusive
38 use designated herein. For purposes of this Subparagraph, "pelletized paper waste"
39 means pellets produced from discarded waste paper that has been diverted or
40 removed from solid waste which is not marketable for recycling and which is wetted,
41 extruded, shredded, or formulated into compact pellets of various sizes for use as a
42 supplemental fuel in a permitted boiler.

43 (o) For the purposes of sales and use taxes imposed or levied by the state or
44 any local governmental subdivision or school board, the term "sale at retail" shall not
45 include the sale or purchase of equipment used in fire fighting by bona fide volunteer
46 and public fire departments.

1 (p) For purposes of state and political subdivision sales and use tax, the term
 2 "sale at retail" shall not include the sale of items, including but not limited to
 3 supplies and equipment, or the sale of services as provided in this Section, which are
 4 reasonably necessary for the operation of free hospitals.

5 (q) For purposes of state and political subdivision sales and use tax, the term
 6 "sale at retail" shall not include:

7 (i) The sale of tangible personal property by approved nonprofit parochial
 8 and private elementary and secondary schools which comply with the court order
 9 from the Dodd Brumfield decision and Section 501(c)(3) of the Internal Revenue
 10 Code, or students, administrators, or teachers, or other employees of the school, if
 11 the money from such sales, less reasonable and necessary expenses associated with
 12 the sale, is used solely and exclusively to support the school or its program or
 13 curricula. This exclusion shall not be construed to allow tax-free sales to students
 14 or their families by promoters or regular commercial dealers through the use of
 15 schools, school faculty, or school facilities.

16 (ii) The sale to approved parochial and private elementary and secondary
 17 schools which comply with the court order from the Dodd Brumfield decision and
 18 Section 501(c)(3) of the Internal Revenue Code of educational materials or
 19 equipment used for classroom instruction limited to books, workbooks, computers,
 20 computer software, films, videos, and audio tapes."

 38 disposition of such cellular, PCS, or wireless telephone, any electronic accessories
 39 that are physically connected with such telephones and personal communication
 40 devices by the dealer to the purchaser, but shall not mean or include the withdrawal,
 41 use, distribution, consumption, storage, donation, or any other disposition of any
 42 such cellular, PCS, or wireless telephone, any electronic accessories that are
 43 physically connected with such telephones, and personal communication devices by
 44 the dealer.

45 (w) For purposes of the imposition of sales and use taxes imposed or levied
 46 by any political subdivision of the state, in the case of the sale or other disposition
 47 by a dealer of any cellular telephone, PCS telephone, wireless telephone, or other
 48 wireless personal communication device that is used in connection with the sale or

1 use of mobile telecommunications services, or any electronic accessory that is
 2 physically connected with any such telephone or personal communication device, the
 3 term "retail sale" or "sale at retail" shall mean and include the sale or any other
 4 disposition of any such telephone, other personal communication device, or
 5 electronic accessory.

6 (x) For purposes of the sales and use tax imposed by the state or any political
 7 subdivision whose boundaries are coterminous with those of the state, the terms
 8 "retail sale" or "sale at retail" shall not include the following:

9 ~~(i) The sale or purchase by a person consumer of any fuel or gas, including~~
 10 ~~but not limited to butane and propane for residential use by that consumer.~~

11 ~~(ii) Beginning July 1, 2008, the sale or purchase by any person of butane and~~
 12 ~~propane.~~

13 (y)(i) Solely for the purposes of sales and use taxes levied by the state ~~or any~~
 14 ~~political subdivision whose boundaries are coterminous with those of the state~~, the
 15 term "sale at retail" shall not include the sale of manufacturing machinery and
 16 equipment used or consumed in this state to manufacture, produce, or extract
 17 unblended biodiesel through March 30, 2016.

18 (ii) As used in this Subparagraph, the following words and phrases have the
 19 meaning ascribed to them:

20 (aa) "Manufacturing machinery and equipment" means tangible property
 21 used or consumed, or held for use or consumption, as an integral part of a biodiesel
 22 manufacturing, production, or extraction facility, process, or item of equipment.
 23 Property shall be considered to be an integral part of such biodiesel manufacturing,
 24 production, or extraction facility, process, or item of equipment only if such property
 25 is used or consumed directly in the manufacturing, production, or extraction process
 26 or is part of, physically attached to, or otherwise directly associated with such
 27 property. Property, the installation of which is reasonably necessary for the proper
 28 installation, operation, maintenance of property which directly results in such
 29 manufacturing, production, or extraction shall be considered as directly associated
 30 with such property.

31 (bb) "Unblended biodiesel" means a fuel comprised of mono-alkyl esters of
 32 long chain fatty acids derived from vegetable oils or animal fats, designated B100,
 33 and meeting the requirements of the definition provided for in D 6751 of the
 34 American Society of Testing and Materials (ATDM D 6751), before such fuel is
 35 blended with a petroleum-based diesel fuel."

1 location within this state and offers only online instruction, when all of the following
2 apply:

3 (i) The textbooks and course-related software are physically outside of this
4 state when purchased from a vendor outside of this state and then imported into this
5 state.

6 (ii) The first student use of the textbooks and course-related software occurs
7 outside of this state.

8 (iii) The textbooks and course-related software are provided to the student
9 free of charge."

37 Crude Oil on December first of the preceding calendar year and the denominator of
38 which shall be twenty-nine dollars, and provided further that such sales price shall
39 be the maximum value placed upon refinery gas by the state and by any political
40 subdivision under any authority or grant of power to levy and collect sales or use
41 taxes, and such sale shall be taxable."

23 in connection with the sale or use of mobile telecommunications services, as defined
24 in R.S. 47:301(10)(v), after January 1, 2002, the term "sales price" shall mean and
25 include the greater of (i) the amount of money actually received by the dealer from
26 the purchaser for each such telephone, or (ii) twenty-five percent of the cost of such
27 telephone to the dealer, but shall not include any amount received by the dealer from
28 the purchaser for providing mobile telecommunications services or any
29 commissions, fees, rebates, or other amounts received by the dealer from any source
30 other than the purchaser as a result of or in connection with the sale of the

 14 the United States Post Office for transportation outside the state, or (2) delivered
 15 outside the state by use of the repair dealer's own vehicle or by use of an independent
 16 trucker. However, as to aircraft, delivery may be by the best available means. This
 17 exclusion shall not apply to sales and use taxes levied by any other parish,
 18 municipality or school board. However, any other parish, municipality or school
 19 board may apply the exclusion as defined in this Subparagraph to sales or use taxes
 20 levied by any such parish, municipality, or school board. Offshore areas shall not
 21 be considered another state for the purpose of this Subparagraph.

 23 Calcasieu Parish, charges for the furnishing of repairs to aircraft shall be excluded
 24 from sales of services, as defined in this Subparagraph, provided that the repairs are
 25 performed at an airport with a runway that is at least ten thousand feet long, one
 26 hundred sixty feet wide, and fourteen inches thick."

7 A. There is hereby established a program for the rebate of state sales and use
8 taxes paid on the purchase of machinery and equipment by eligible businesses, to be
9 administered by the secretary of the Department of Revenue. The program is
10 established as a successor policy to various Louisiana state sales and use tax
11 exemptions and exclusions for certain machinery and equipment for purposes of
12 state taxes, which policy was repealed March 30, 2016.

13 B. The following types of business are eligible for the rebate.

14 (1) A person whose principal activity is manufacturing and who is assigned
15 by the Louisiana Workforce Commission a North American Industrial Classification
16 System code within the agricultural, forestry, fishing, and hunting Sector 11, the
