9	One Million Five Hundred Eighty-Nine Thousand Two Hundred Seven and No/100
0	(\$1,589,207.00) Dollars.
1	Section 2A. The Legislative Budgetary Control Council is hereby authorized and
12	directed to reduce the Fees and Self-Generated Revenue appropriation contained in Act No.
13	76 of the 2015 Regular Session of the Legislature for the Louisiana Legislature in the
4	amount of Four Hundred Forty-Four Thousand Thirty-Six and No/100 (\$444,036.00)

16	B. The treasurer is authorized and directed to transfer the Fees and Self-Generated

Further authorizes and directs the treasurer to transfer the Fees and Self-Generated Revenues to the state general fund.
