AN ACT

To amend and reenact R.S. 36:231(C)(1), to enact R.S. 36:238(C) and R.S. 30:2011(C)(1)(b), and to repeal R.S. 30:2011(D)(26), relative to the offices of the Department of Environmental Quality; to provide for the purposes of the offices within the Department of Environmental Quality; to create the office of environmental assessment; to provide terms, conditions, and requirements; and to provide for related matters.

Be it enacted by the Legislature of Louisiana:

Section 1. R.S. 36:231(C)(1) is hereby amended and reenacted and R.S. 36:238(C) is hereby enacted to read as follows:

§231. Department of Environmental Quality; creation; domicile; composition; purposes and functions

* * *

C.(1) The Department of Environmental Quality shall be composed of the executive office of the secretary, the office of management and finance, **the office of environmental assessment**, the office of environmental compliance, and the office of environmental services.

SB 140 Original 2016 Regular Session Walsworth

Present law provides that the secretary of the Dept. of Environmental Quality is responsible for the functions of environmental air quality assessment, water quality assessment, remediation services, and laboratory services and must assign each of these functions to either the office of environmental compliance or the office of environmental services.

Proposed law repeals present law.

Proposed law creates the office of environmental assessment.

Proposed law provides that the office of environmental assessment must provide for environmental air quality assessment, water quality assessment, and technology and must

administer all remediation services and such duties as delegated by the secretary.

Effective August 1, 2016.
