

HOUSE COMMITTEE AMENDMENTS

2016 First Extraordinary Session

Amendments proposed by House Committee on Appropriations to Engrossed Senate Bill No. 9 by Senator Donahue

1 AMENDMENT NO. 1

2 On page 5, between lines 20 and 21, insert the following:

3 "Section 3. Notwithstanding any provision of the law to the contrary, the state
4 treasurer is hereby authorized and directed to transfer Fees and Self-generated Revenues
5 from the Department of Veterans Affairs in the amount of \$5,100,000 into the State General
6 Fund (Direct) as enacted in the bill that originated as HB 122 of the 2016 First Extraordinary
7 Session of the Legislature.

8 Section 4. Notwithstanding any provision of the law to the contrary, the state
9 treasurer is hereby authorized and directed to transfer State Bond Commission Fees and Self-
10 generated Revenues in the amount of \$8,000,000 into the State General Fund (Direct) as
11 enacted in the bill that originated as HB 122 of the 2016 First Extraordinary Session of the
12 Legislature.

13 Section 5. Notwithstanding any provision of law to the contrary, the state treasurer
14 is hereby authorized and directed to transfer out of the Fiscal Year 2015-2016 Deficit
15 Elimination Fund the amount of \$200,000,000 into the State General Fund (Direct) to
16 provide a source of funds to eliminate all or a portion of the Fiscal Year 2015-2016
17 budgetary deficit."

18 AMENDMENT NO. 2

19 On page 5, at the beginning of line 21, change "Section 3." to "Section 6."

20 AMENDMENT NO. 3

21 On page 5, line 22, after "provided in" and before "this" insert "Sections 2, 3, and 8 of"

22 AMENDMENT NO. 4

23 On page 6, between lines 1 and 2, insert the following:

24 "Section 7.(A) All transfers authorized in this Act shall be effectuated prior to any
25 other further appropriation from the fund. In the event that there are insufficient monies to
26 fully fund the transfers required by this Act, the treasurer shall notify the commissioner of
27 administration and the Joint Legislative Committee on the Budget.

28 (B) The state treasurer shall make all transfers in Sections 4 and 5 of this Act prior
29 to the end of Fiscal Year 2015-2016. In the event that the amounts available to be
30 transferred to the State General Fund (Direct) pursuant to Sections 4 and 5 are insufficient
31 to fully fund the transfers required in this Act, the treasurer shall notify the commissioner
32 of administration and the Joint Legislative Committee on the Budget.

33 Section 8.(A) In the event that the amount of any reduction in the appropriation out
34 of a fund contained in the Act that originated as House Bill 122 of the 2016 First
35 Extraordinary Session of the Legislature is different from the amount specified in this Act,
36 the state treasurer shall transfer the amount specified in the Act which originated as House
37 Bill 122.

1 (B) The state treasurer is hereby authorized and directed to transfer the amounts
2 provided from any funds specified in House Bill 122 of the 2016 First Extraordinary Session
3 of the Legislature that are not specified in this Act. "

4 AMENDMENT NO. 5

5 On page 6, at the beginning of line 2, change "Section 4." to "Section 9."
