Current law requires the losses from the earliest taxable year be used first to reduce net income in the of a tax filing.

Proposed law changes the order of loss use to the loss for the most recent taxable year.

Effective on January 1, 2107.

EXPENDITURE EXPLANATION

There is no anticipated direct material effect on governmental expenditures as a result of this measure.

REVENUE EXPLANATION

Current law allows net operating losses from as far back as twenty years ago to be deducted from net income on a current tax return. This reduces current taxable income, tax liabilities, and tax receipts. Current law also requires that the oldest losses be deducted from current net income first. This facilitates the maximum utilization of the stock of available losses lover time. This bill will require that the newest losses be utilized. This is not likely to change the aggregate amount of loss deduction on current returns for the next few years, it may work to reduce the total stock of loses available to use over time as the oldest losses expire without being utilized. However, newer losses will continue to be accumulated and a twenty year stock of losses will always be allowed to be utilized. The effect of the bill on the amount of losses available to deduct will depend on the relative size of newer versus older losses.
