COMMENDATIONS: Commends Tim Detillier upon his retirement as head coach of Lutcher High School football team

1 A RESOLUTION

2 To commend Tim Detillier upon his retirement as head coach of the Lutcher High School  
3 football team.

4 WHEREAS, after thirty-eight years of highly effective and inspirational coaching,  
5 Tim Detillier has decided to retire as head coach of the Lutcher High School football team;  
6 and

7 WHEREAS, in 1978, Tim Detillier was hired as the running back and receiver coach  
8 and the head baseball coach for the Lutcher High School Bulldogs; and

9 WHEREAS, in 1980, he was named the offensive coordinator; in 1983, he was the  
10 play caller for the state champion Bulldogs; and

11 WHEREAS, in 1984, Coach Detillier accepted the head coach position at St. Charles  
12 Catholic; he returned to Lutcher High School in 1991 to become head coach of the football  
13 team; and

14 WHEREAS, Coach Detillier's commitment and loyalty to coaching is unmatched;  
15 Coach Detillier's teams have made the playoffs thirty-six out of the thirty-eight years of his  
16 coaching career; and

17 WHEREAS, Coach Detillier is the all-time winningest coach in the river parishes and  
18 is ranked thirteenth on Louisiana's all-time wins list; as head coach for the Bulldogs, he has  
19 won 3-A state championships in 2003, 2006, 2008, and 2015; and

20 WHEREAS, at Lutcher High School, Coach Detillier also served as the athletic  
21 director; and

1           WHEREAS, Coach Detillier has been active with the Louisiana High School Athletic  
2 Association, the Louisiana High School Coaches Association, the Louisiana High School  
3 Athletic Directors Association, and the Louisiana Football Coaches Association; and

4           WHEREAS, in 1993, Coach Detillier served as president of the Louisiana High  
5 School Coaches Association, and he also served on the Louisiana High School Athletic  
6 Association's school relations and executive committees; in November of 2014, Coach  
7 Detillier was a finalist for the Louisiana High School Athletic Association's executive  
8 director position; and

9           WHEREAS, Coach Detillier will always be respected and admired for the wonderful  
10 guidance he gave to his players both on and off the field, as he challenged them to succeed  
11 not only as athletes but as well-rounded human beings; upon the end of his monumental  
12 coaching career at Lucher High School, Coach Detillier merits a special measure of  
13 commendation for his outstanding accomplishments and his enduring legacy that will long  
14 continue to be a source of tremendous pride for the innumerable players, coworkers, and fans  
15 whose lives he touched during his unforgettable coaching career.

16           THEREFORE, BE IT RESOLVED that the House of Representatives of the  
17 Legislature of Louisiana does hereby commend Tim Detillier upon his retirement as head  
18 coach of the Lucher High School football team; does hereby express to him sincere  
19 appreciation for his exemplary leadership and for the honor he has brought to the school,  
20 community, and the state of Louisiana; and does hereby extend to him every good wish for  
21 success and happiness in all of his future endeavors.
