APPROPRIATIONS/JUDGMENT: Appropriates funds for payment of judgment against the state in "Board of Supervisors of Louisiana State University and Agricultural and Mechanical College v. Michael P. Villavaso"

AN ACT

2 To appropriate funds out of the General Fund of the state of Louisiana for Fiscal Year 2016-3 2017 to be used to pay the judgments in the suit entitled "Board of Supervisors of 4 Louisiana State University and Agricultural and Mechanical College v. Michael P. 5 Villavaso"; to provide for interest; to provide for court costs; to provide for attorney 6 fees; and to provide for related matters. 7 Be it enacted by the Legislature of Louisiana: 8 Section 1. The sum of Two Hundred Forty Thousand Six Hundred Thirty-Eight and 9 No/100 (\$240,638.00) Dollars, plus the sum of One Hundred Sixty-Five Thousand and 10 No/100 (\$165,000.00) for attorney fees, plus the sum of Thirty-Seven Thousand Seven 11 Hundred Fourteen and 51/100 (\$37,714.51) for costs, plus legal interest at 5% per annum 12 from July 14, 2014 until paid, is hereby appropriated out of the General Fund of the state of 13 Louisiana for Fiscal Year 2016-2017 to be used to pay the judgments in the suit entitled 14 "Board of Supervisors of Louisiana State University and Agricultural and Mechanical 15 College v. Michael P. Villavaso", bearing Number 11-3852, Division "D", Section "16", on 16 the docket of the Civil District Court, parish of Orleans, state of Louisiana. 17 Section 2. The judgment provided for in Section 1 hereof shall be deemed to have 18 been paid on the effective date of this Act and legal interest shall cease to run as of that date.

- 1 Section 3. This Act shall become effective on July 1, 2016; if vetoed by the governor
- 2 and subsequently approved by the legislature, this Act shall become effective on July 1,
- 3 2016, or on the day following such approval by the legislature, whichever is later.
