2	To commend Dr. D.K. Haynes for more than forty years of service to the public health
3	system.
4	WHEREAS, throughout the years, Dr. Haynes has provided family planning services
5	at the Claiborne Parish Health Unit for thousands of women; and
6	WHEREAS, at the age of eighty-two, Dr. Haynes is a cancer survivor who still sees
7	patients on a limited basis, teaches medical students in Shreveport, and serves as the coroner
8	in Claiborne Parish; and
9	WHEREAS, in 1951, he graduated from Lisbon High School, and he furthered his
10	education at Louisiana Tech University; he attended medical school at Louisiana State
11	University (LSU) School of Medicine in New Orleans; he served his internship at
12	Confederate Memorial Hospital in Shreveport and completed his residency at Lafayette
13	Charity Hospital; and
14	WHEREAS, in 1960, Dr. Haynes established his private practice, Gladney-Haynes
15	Clinic in Homer; in 1988, he moved to Claiborne Family Medical Clinic, where he continues
16	to practice; and
17	WHEREAS, he served as the chief of staff at Homer Memorial Hospital and has been
18	clinical professor at LSU Medical School since 1978; and
19	WHEREAS, a most deserving recipient of a variety of awards, Dr. Haynes was
20	named Louisiana Family Doctor of the Year in 1983, Preceptor of the Year in 1983 for the

Comprehensive Clinic-LSU Medical Center, and in 1958, he was inducted into the Honor

2 Medical Society at LSU; and 3 WHEREAS, he is a charter member of the American Board of Family Practice and 4 a charter fellow of the American Academy of Family Physicians; he is a past speaker of the 5 House of Delegates and the Louisiana Academy of Family Practice, and a member of the 6 American Academy of Family Physicians, the Louisiana Academy of Family Practice, the 7 Louisiana State Medical Society, the Claiborne Parish Medical Society, and the Southern 8 Medical Association; and 9 WHEREAS, Dr. Haynes has dedicated countless hours of service to his community 10 as a deacon at Homer First Baptist Church; he also served on the board of directors for 11 Homer Memorial Hospital, as chairman of the board for Claiborne Academy, a member of 12 the Homer Chamber of Commerce, a board member for the Claiborne Parish Chapter of the 13 American Cancer Society, a board member for the Claiborne Parish Chapter of the American 14 Heart Association, a member of the Homer Jaycees, in which he received the Distinguished 15 Service Award and the Young Man of the Year Award, and he was a Century Member of 16 the Norwela Council Boy Scouts of America; and 17 WHEREAS, in 1954, Dr. Haynes married Carolyn Kimbell, and the couple remained 18 married for fifty-six years until her death in 2010; they raised five children, Mark, Scott, 19 John, Keith, and Lisa; he is a proud grandfather and great-grandfather; and 20 WHEREAS, Dr. D.K. Haynes is one of Louisiana's finest sons, and he merits the 21 highest measure of commendation for his many years of service to the public health system. 22 THEREFORE, BE IT RESOLVED that the House of Representatives of the 23 Legislature of Louisiana does hereby commend Dr. D.K.
