2 On page 1, line 7, after "intent;" and before "and" insert "to provide for effectiveness;"

3 AMENDMENT NO. 2

4 On page 1, at the end of line 14, change "residential" to "residential, public"

5 AMENDMENT NO. 3

6 On page 2, line 23, after "(4)" and before "means" change "State Board" to "State board"

7 AMENDMENT NO. 4

8 On page 2, at the end of line 27, change "residential" to "residential, public"

9 AMENDMENT NO. 5

10 On page 3, line 4, after "to" delete the remainder of the line and insert "public schools as"

11 AMENDMENT NO. 6

12 On page 3, line 9, after "this" and before "referred" change "part" to "Part"

13 AMENDMENT NO. 7

14 On page 3, delete line 11, and insert the following:

15 "(1) A member selected by the state superintendent of education."

16 AMENDMENT NO. 8

17 On page 3, line 28, after "board" delete the remainder of the line and insert "may:"

18 AMENDMENT NO. 9

19 On page 4, at the end of line 18, add the following:

20 "All such certificates and diplomas shall be in addition to a regular high
21 school diploma which shall be issued by the state board in accordance with
22 the provisions of R.S. 17:6(A)(11) to any student who successfully completes
23 the program of study adopted by the board."

25 On page 4, at the end of line 24, change "may deem" to "deems"

26 AMENDMENT NO. 11

27 On page 5, line 4, after "granted" and before "and any" change "herein" to "by this Section"

1 AMENDMENT NO. 12

2 On page 5, at the end of line 9, add the following:

3 "In enrolling students, preference shall be given to students with the greatest
4 need based on the criteria specified in R.S. 17:1972(1) as determined by the
5 board."

6 AMENDMENT NO. 13

7 On page 5, delete line 12, and insert "jurisdiction."

8 AMENDMENT NO. 14

9 On page 5, line 23, after "not" and before "restricted" delete "necessarily"

10 AMENDMENT NO. 15

11 On page 6, at the beginning of line 14, change "duties" to "service"

12 AMENDMENT NO. 16

13 On page 6, delete lines 15 and 16 in their entirety and insert the following:

14 "G. The school shall act as its own local education agency."

15 AMENDMENT NO. 17

16 On page 6, line 21, after "system" delete the remainder of the line and at the beginning of
17 line 22, delete "cannot," and insert "offers at other schools which the school does not offer,"

18 AMENDMENT NO. 18

19 On page 7, line 4, after "recommended" and before "to" change "formula" to "budget"

20 AMENDMENT NO. 19

21 On page 7, line 5, after "The" and before "shall have" change "formula" to "budget"

22 AMENDMENT NO. 20

23 On page 7, line 8, after "recommended" and before "shall" change "formula" to "budget"

24 AMENDMENT NO. 21

25 On page 7, line 10, after "(2)" and before "for" change "Funding" to "In addition to any
26 funds provided pursuant to R.S. 17:1974(D)(1), funding"

27 AMENDMENT NO. 22

28 On page 7, delete lines 11 through 26 in their entirety and insert "appropriation made
29 directly to the school or through funds appropriated for the minimum foundation program,
30 or both."

31 AMENDMENT NO. 23

32 On page 8, delete line 8, and insert the following:

1 "(9) The board of directors of Thrive Academy (R.S. 17:1971 et
2 seq.)."

3 AMENDMENT NO. 24

4 On page 8, after line 9, insert the following:

5 "Section 3. This Act shall become effective on July 1, 2017, except
6 that the provisions of R.S. 17:1974 as provided in this Act relative to the
7 creation and functions of the board of directors shall become effective on
8 October 1, 2016."
