9 WHEREAS, Addison serves as historian of the student council, secretary of the  
10 National Honor Society, editor-in-chief of the *Topper*, and she is currently the senior class  
11 representative; she is also a proud member of the ACT 23+ Club; and

12 WHEREAS, she was chosen to serve as president of the leadership team for the  
13 youth group of First United Methodist Church; and

14 WHEREAS, she plans to attend Louisiana State University Eunice to receive an  
15 associate degree in elementary education and the University of Louisiana at Lafayette to  
16 receive a bachelors degree; and

17 WHEREAS, Caleb King is the son of Steven and Anne King; he is a senior at  
18 Northside Christian School, where he maintains a 3.93 GPA; he placed second in the fine  
19 arts survey and third in geometry at the District Literary Rally; he also received the Coaches  
20 Award for varsity basketball; and

1           WHEREAS, Caleb was chosen as Mr. Northside Christian for 2016, and he received  
2 the National Beta Club leadership scholarship; and

3           WHEREAS, he has played basketball for four years and baseball for three years; and

4           WHEREAS, he has served as vice president for Beta Club, senior class  
5 representative, and he was a member of the school chapel worship team; and

6           WHEREAS, Caleb plans to attend a discipleship school for five months before  
7 attending the University of Louisiana at Lafayette in 2017 to pursue a career in physical  
8 therapy; and

9           WHEREAS, Sybil Lorraine Duncan is the daughter of Shea and Kathy Duncan; she  
10 is a senior at Notre Dame High School, where she maintains a 3.86 GPA; and

11           WHEREAS, she has been named to the Principal's List and the Honor Roll, and she  
12 received academic all state honors in track and field and the Ochsner of New Orleans STAR  
13 Award for all A's; and

14           WHEREAS, she has been a member of the pep squad, the basketball team, the soccer  
15 team, the cross country team, and the track and field team; and

16           WHEREAS, she is an active member of St. Michael's Catholic Church, where she  
17 serves as a Eucharistic minister; in March, she traveled to the Dominican Republic for a  
18 mission trip; and

19           WHEREAS, Sybil plans to attend Louisiana State University to major in biology; she  
20 hopes to attend medical school and become a doctor; and
