SPECIAL DAY/WEEK/MONTH: Designates Thursday, May 5, 2016, as Louisiana Society of Professional Surveyors Day at the state capitol

1 A RESOLUTION

2 To designate Thursday, May 5, 2016, as Louisiana Society of Professional Surveyors Day
3 at the state capitol.

4 WHEREAS, professional surveying is celebrating its one hundred seventh year of
5 licensure; the first licenses, numbered one, two, and three, were issued to J.B. Bice, C.P.
6 Couvillion, and R.A. Crowson, respectively, in 1908; and

7 WHEREAS, licensed professional surveyors are compelled to follow rules of
8 professional conduct in order to safeguard life and health, to protect property, to promote the
9 welfare of the public, and to establish and maintain a high standard of integrity in the
10 performance of their professional duties; and

11 WHEREAS, licensed professional surveyors, at all times, recognize that their
12 primary obligation is to protect the safety, health, property, and welfare of the public; and

13 WHEREAS, licensed professional surveyors are committed to cooperating with
14 educational institutions to maintain high standards of education in land surveying; and

15 WHEREAS, licensed professional surveyors are committed to maintaining the
16 highest levels of professional quality and to keeping abreast of the most advanced
17 technological developments in their field, including utilizing global positioning, mapping,
18 and spatial referencing as they seek to provide state-of-the-art surveying services to the
19 citizens of Louisiana.

20 THEREFORE, BE IT RESOLVED that the House of Representatives of the
21 Legislature of Louisiana does hereby commend the Louisiana Society of Professional

1 Surveyors and its members across the state for their significant contributions in service to
2 the citizens of Louisiana since licenses were first issued in 1908.

3 BE IT FURTHER RESOLVED that the House of Representatives of the Legislature
4 of Louisiana does hereby designate Thursday, May 5, 2016, as Louisiana Society of
5 Professional Surveyors Day at the state capitol.

6 BE IT FURTHER RESOLVED that a suitable copy of this Resolution be transmitted
7 to the president of the Louisiana Society of Professional Surveyors.
