2 On page 6, between lines 8 and 9, insert the following:

3 "G. The secretary shall not lease any water bottom located within  
4 seventy-five feet of the centerline of a pipeline that is located on purchased  
5 right-of-way. However, if the right-of-way is abandoned and returned to  
6 commerce, the secretary may then lease such water bottom."

8 On page 7, line 10, after "(a)" delete the remainder of the line and on line 11, delete "leases  
9 that were not renewed by the"

10 AMENDMENT NO. 14

11 On page 10, line 26, change "processed" to "received" and at the end of the line add the  
12 following:

13 "Any water bottom for which there is a pending application under Phases  
14 One, Two, or Three shall not be eligible for leasing under Phase Four."

15 AMENDMENT NO. 15

16 On page 11, line 17, change "processed" to "received" and at the end of the line add the  
17 following:

18 "Any water bottom for which there is a pending application under Phases  
19 One, Two, Three, of Four shall not be eligible for leasing under Phase Five."

20 AMENDMENT NO. 16

21 On page 12, after line 28, add the following:

22 "Section 4. This Act shall take effect and become operative if and  
23 when the Act that originated as House Bill No. 1130 of this 2016 Regular  
24 Session of the Legislature is enacted and becomes effective."
