**TAB 4 - LOCAL POLITICAL SUBDIVISIONS - LOANS**

3. **L09-178 - Acadia Parish Convention and Visitors Bureau** - Not exceeding \$570,000 Certificates of Indebtedness, not exceeding 8%, not exceeding 10 years, purchase immovable property.
4. **L09-166 - Allen Parish, Hospital Service District No. 3** - Not exceeding \$500,000 Revenue Anticipation Notes, 2.88%, maturing on or before June 1, 2010, paying the cost of current expenses for the fiscal years ending June 30, 2009 and June 30, 2010.
5. **L09-163 - Catahoula Parish, Village of Sicily Island** - Not exceeding \$25,000 Excess Revenue Loan, not exceeding 2 years and not exceeding 7%, paying overdue bills incurred over the years.
6. **L09-181 - Evangeline Parish Police Jury, Road District No. 4** - \$775,000 Certificates of Indebtedness, not exceeding 4%, maturing March 31, 2019, to pay costs of constructing and improving roads and highways.
7. **L09-158 - Lafourche Parish Law Enforcement District** - Not exceeding \$1,000,000 Certificates of Indebtedness, not exceeding 6%, not to exceed 10 years, purchasing and implementing a comprehensive fully integrated public safety information management system (department wide including necessary hardware) and to enhance/improve the LPSO training academy building.
8. **L09-162 - Ouachita Parish, City of West Monroe** - Not exceeding \$3,000,000 Certificates of Indebtedness, not exceeding 6%, not exceeding 10 years, capital improvements, including street improvements.
9. **L09-170 - St. James Parish Council** - Not exceeding \$800,000 Limited Tax Certificates, not exceeding 5%, not exceeding 5 years, constructing and improving the public hospital buildings.
10. **L09-174 - St. John the Baptist Parish School Board** - Not exceeding \$500,000 Certificates of Indebtedness, not exceeding 4.5%, maturing no later than 5 years after issuance, purchasing copying and document reproduction equipment.
11. **L09-176 - Terrebonne Parish, Bayou Cane Fire Protection District** - Not exceeding \$450,000 Limited Tax Certificates of Indebtedness, not exceeding 6%, not exceeding 5 years, purchasing a fire truck.
12. **L09-192 - Union Parish Police Jury** - Not exceeding \$4,039,000 Letter of Credit, 1 year, closure or post-closure costs of the Union Parish Landfill, and to issue in connection therewith a note or other evidence of indebtedness in the nominal principal amount of the Letter of Credit, not exceeding 6%, 1 year.

13. **L09-175 - Vermilion Parish School Board** - \$1,400,000 Certificates of Indebtedness, not exceeding 5%, February 1, 2019, constructing and equipping a new cafeteria at Meaux Elementary School.
14. **L09-165 - Vernon Parish Law Enforcement District** - Not exceeding \$900,000 Promissory Note, not exceeding 6%, maturing on or before March 1, 2010 for general operations.

15. **L07-455A - St. Tammany Parish Hospital Service District No. 2** - \$17,500,000 General Obligation Bonds, not exceeding 7%, not exceeding 20 years, for constructing, acquiring, extending and improving a full service Cancer Center and related health care facilities of the District, and acquiring equipment and furnishings thereof to be located in Slidell.

16. **L09-172 - Iberville Parish, Waterworks District No. 2** - Notice of Intention to issue not exceeding \$3,250,000 Water Revenue Bonds, or other debt obligations, not exceeding 5%, not exceeding 22 years, constructing and acquiring additions, extensions and improvements to the waterworks system.
17. **L09-179 - St. Mary Parish, City of Morgan City** - Notice of Intention to issue not exceeding \$5,000,000 Sewer Revenue Bonds, not exceeding 6%, maturing over a period not exceeding 22 years, constructing and acquiring improvements and extensions to the sewer systems, including the payment of the cost of all necessary land, equipment and furnishings, and all engineering, legal and other incidental costs and fees incurred in connection therewith.
18. **L09-180 - St. Mary Parish, City of Morgan City** - Notice of Intention to issue not exceeding \$2,000,000 Utility Revenue Bonds, not exceeding 6%, maturing over a period not exceeding 22 years, constructing and acquiring improvements and extensions to the combined waterworks plants and systems, the electric light and power plants and systems and the natural gas transmission and distribution plants and systems, including the payment of the cost of all necessary land, equipment and furnishings, and all engineering, legal and other incidental costs and fees incurred in connection therewith.
19. **L09-186 - West Baton Rouge Parish, Town of Addis** - Notice of Intention to issue not exceeding \$1,750,000 Sewer Revenue Bonds, not exceeding 0.95%, not exceeding 22 years, constructing and acquiring additions, extensions and improvements to the sewerage collection and disposal system.

21. **L09-168 - Calcasieu Parish School Board, School District No. 34** - Not exceeding \$9,000,000 General Obligation Refunding Bonds, not exceeding 4.5%, maturing not later than January 15, 2024, currently refund General Obligation Public School Improvement Bonds, Series 2004.

22. **L09-169 - Calcasieu Parish School Board, School District No. 33** - Not exceeding \$9,000,000 General Obligation Refunding Bonds, not exceeding 4.5%, maturing not later than January 15, 2024, currently refund General Obligation Public School Improvement Bonds, Series 2004.
23. **L09-065A - Lafourche Parish, City of Thibodaux** - Not exceeding \$8,000,000 Water Revenue Bonds, Series 2009, not exceeding 8%, maturing no later than 22 years, constructing and acquiring improvements and extensions to the waterworks system, including all appurtenant equipment, accessories and properties, both personal and real.
24. **L09-167 - St. Charles Parish School Board** - Not exceeding \$8,600,000 Sales Tax School Refunding Bonds, not exceeding 5%, maturing no later than February 1, 2019, refunding the callable maturities of Sales Tax School Bonds, Series 1999.
25. **L09-189 - St. Charles Parish Law Enforcement District** - Not exceeding \$15,600,000 Limited Tax Refunding Bonds, not exceeding 6%, not exceeding 20 years, (i) refunding and extending the Issuer's Obligation under a Loan Agreement dated as of April 1, 1999, between the Issuer and the Louisiana Local Government Environmental Facilities and Community Development Authority and (ii) purchasing, building, acquiring and improving law enforcement facilities including equipment and furnishings therefor.
26. **L09-171 - St. Tammany Parish Council** - Not exceeding \$1,000,000 Utility Revenue Bonds, not exceeding 0.95%, not exceeding 22 years, design and engineering of additions, improvements and upgrades to the sewerage component of the sewage collection, treatment and disposal systems and the waterworks treatment and distribution systems and the construction and acquisition of improvements to said sewerage component of the System.
27. **L09-173 - St. Tammany Parish Gravity Drainage District No. 5, Sub-Drainage District No. 3** - Not exceeding \$220,000 Parcel Fee bonds, Series 2009, to mature over a period not exceeding 10 years, not exceeding 6%, making capital improvements to improve drainage.
28. **L09-177 - Terrebonne Parish, Consolidated Waterworks District No. 1** - Not exceeding \$6,200,000 Water Revenue Refunding Bonds, Series 2009, not exceeding 4.50%, and maturing not later than November 1, 2017, refunding Water Revenue Bonds, Series 1998.

32. **L09-183 - Industrial Development Board of the City of New Orleans, Louisiana, Inc. (Chateau Carre Apartments Project)** - Not exceeding \$17,500,000 Multifamily Housing Revenue Bonds, acquisition, rehabilitation and installation of a 150 unit residential rental facility serving low and moderate income families in New Orleans.
33. **L09-184 - Industrial Development Board of the City of New Orleans, Louisiana, Inc. (New Savoy Place Phase II Project)** - Not exceeding \$3,250,000 Multifamily Housing Revenue Bonds, redevelopment, construction and operation of the former public housing site known as Desire Village located in New Orleans, which is the final phase of the Savoy Post-Katrina redevelopment effort as well as the final rental phase of the Desire Village HOPE VI Revitalization Plan consisting of the new construction of a 160 unit residential rental facility serving low and moderate income families.
34. **L09-188 - Industrial Development Board of the Parish of St. Mary, Louisiana, Inc. (Charenton Canal, L.L.C. Project)** - Not exceeding \$10,000,000 Revenue Bonds, (i) acquisition of approximately 25 acres of land on the Charenton Canal in Franklin, (ii) bulkheading the water frontage, (iii) building a 250' by 50' slip to accommodate a 500-ton capacity travel lift which is to be acquired, and (iv) construction of a 50,000 square foot fabrication facility, a 25,000 square foot storage facility, a 10,000 square foot office facility, and a 6,000 square foot employee facility.
