3. **L13-368 - Bienville Parish, Village of Saline** - 1% sales tax, to be levied in perpetuity, beginning January 1, 2014, support the general fund.
4. **L13-367 - Catahoula Parish, Fire Protection District No. 4** - 10 mills tax, 10 years, 2014-2023, (1) acquiring, constructing, improving, maintaining and/or operating fire protection facilities and equipment and (2) paying the cost of obtaining water for fire protection purposes.
5. **L13-385 - East Baton Rouge Parish, Central Community School Board, Central Community School System** - Not exceeding \$13,100,000 General Obligation Bonds, not exceeding 7%, not exceeding 20 years, (1) improving facilities at Central High, including construction of a Ninth Grade Academy Building, parking lot repairs and lighting of ball fields; (2) District-wide technology improvements and (3) demolition, asbestos abatement and parking upgrade at old Central Middle School.
6. **L13-393 - East Baton Rouge Parish, Park Forest Crime Prevention and Improvement District** - \$75 parcel fee, 10 years, 2014-2023, (1) aid in crime prevention and enhance security of residents by providing for an increase of law enforcement personnel or contracted security personnel and (2) creation of a crime free housing program and other purposes permitted by applicable law.

8. **L13-366 - East Carroll Parish Police Jury** - (1) 1% sales tax, 10 years, beginning January 1, 2014, (a) constructing, operating and maintaining Parish Public roads, drainage canals and bridges; (b) 10% of the proceeds to be used exclusively for insurance premiums; (2) 1.82 mills tax, 10 years, 2015-2024, constructing, improving, maintaining, operating and supporting facilities and programs for the elderly through the East Carroll Council on Aging; (3) 2.53 mills tax, 5 years, 2015-2019, utility expense and building upkeep and maintenance of the East Carroll Parish Courthouse Buildings; (4) 8.22 mills tax, 5 years, 2015-2019, operating and maintaining the East Carroll Parish Library and Bookmobile; (5) 2.74 mills tax, 5 years, 2015-2019, operating, maintaining and supporting the Louisiana Cooperative Extension Program, including providing necessary office facilities, equipment and supplies, with no more than 3% of annual proceeds to be retained by the Police Jury for its cost of administering the Tax; (6) 2 mills tax, 3 years, 2014-2016, maintaining and operating programs through the East Carroll Community Actions Agency.
9. **L13-370 - Grant Parish Economic Development District** - 2% sales tax, 10 years, beginning January 1, 2014, (1) 50% for maintenance, improvement and support of infrastructure and (2) 50% for promotion and support of economic development.

10. **L13-371 - Lafourche Parish, Central Lafourche Ambulance Service District** - 8 mills tax, 10 years, 2014-2023, (1) contracting for private ambulance service and/or (2) acquiring, maintaining and operating equipment and facilities necessary to provide ambulance service.
11. **L13-372 - Lincoln Parish School Board, Ruston School District No. 1** - Not exceeding \$21,000,000 General Obligation Bonds, in one or more series, not exceeding 8%, not exceeding 20 years, (1) acquiring and/or improving lands for building sites and playgrounds; including construction of necessary sidewalks and streets; (2) purchasing, erecting and/or improving school buildings and other school related facilities, including, to the extent feasible, those specific school projects set forth in the “Capital Improvements Plan” approved by the School Board on July 25, 2013 and (3) acquiring necessary equipment and furnishings.
12. **L13-354 - Orleans Parish, City of New Orleans, Eastover Neighborhood Improvement and Security District** - \$1,652 parcel fee, to be levied in perpetuity, beginning January 1, 2014, promote and encourage the beautification, security and overall betterment as determined by the Board of Directors of the Eastover Property Owners Association.
