3. **L14-197 - Ascension Parish Council** - 5 mills tax, 10 years, 2015-2024, (1) acquiring, constructing, improving, maintaining and/or operating recreational facilities and activities and (2) funding into bonds.
4. **L14-198 - Ascension Parish, Fire Protection District No. 3** - (1) 10 mills tax, 10 years, 2015-2024, (a) development, operation and maintenance of fire protection facilities, (b) paying costs of obtaining water for fire protection purposes, including charges for fire hydrant rentals and service and (c) salaries of firemen; (2) \$32 parcel fee for residential lots, \$100 for commercial lots, 10 years, 2015-2024, (a) acquisition, construction, maintenance and operation of fire protection facilities and equipment, including costs of obtaining water for fire protection purposes and (b) salaries of firemen.

15. **L14-192 - Catahoula Parish Police Jury** - 1% sales tax, 10 years, beginning April 1, 2015, proceeds to be allocated between the Parish and incorporated municipalities: 75% Police Jury, 16.5% Jonesville, 5% Sicily Island, and 3.5% Harrisonburg. for constructing, acquiring, extending, improving, maintaining and/or operating garbage collection and disposal facilities and equipment, provided that 25% of the Police Jury's 75% portion will continue to be used for constructing, improving, maintaining and repairing gravel roads and bridges, including necessary supplies, materials and equipment.

21. **L14-227 - East Baton Rouge Parish, Metropolitan Council of the Parish of East Baton Rouge and City of Baton Rouge, Fire Protection District No. 1** - 9 mills tax, 5 years, 2016-2020, (1) development, operation and maintenance of the fire protection facilities and (2) paying cost of obtaining water for fire protection purposes, including charges for fire hydrant rentals and service.
22. **L14-250 - East Carroll Parish, Town of Lake Providence** - 1% sales tax, 10 years, beginning March 31, 2015, improvement, maintenance, and/or repair of public streets, including but not limited to the acquisition, maintenance, and repair of equipment for such purpose.
23. **L14-221 - East Feliciana Parish, Parishwide Fire Protection District** - \$48 annual tax for residential or commercial structures, \$38 for mobile homes, 10 years, 2015-2024, fire protection services and emergency services, including acquisition, maintenance and operation of equipment and facilities.

32. **L14-246 - Livingston Parish, Fire Protection District No. 5** - 10.14 mills tax, 10 years, 2015-2024, (1) maintaining, operating and developing fire protection facilities; (2) purchasing fire trucks and other firefighting equipment; (3) paying the cost of obtaining water for fire protection purposes, including charges for fire hydrants rentals and service and (4) acquiring, improving or constructing fire protection facilities.
33. **L14-233 - Livingston Parish, Recreation District No. 2** - 15 mills tax, 10 years, 2015-2024, constructing, improving, maintaining and operating the recreational facilities.
34. **L14-237 - Livingston Parish, Recreation District No. 3** - 15 mills tax, 10 years, 2016-2025, operating and maintaining said District.
35. **L14-248 - Livingston Parish, Town of Killian** - ½% sales tax, to be levied in perpetuity, beginning January 1, 2015, public safety.
36. **L14-207 - Natchitoches Parish, Fire Protection District No. 2** - 7.08 mills tax, 10 years, 2015-2024, acquiring, constructing, improving, maintaining and/or operating fire protection facilities and equipment, including paying the cost of obtaining water for fire protection purposes.
37. **L14-217 - Orleans Parish, City of New Orleans** - Amendment to Sections 6-308(1) and 6-308(5)(b) of the Home Rule Charter, relative to written contracts to which the City is a party.
