3. **L15-150 - Beauregard Parish, Town of Merryville** - ¼% sales tax, 10 years, beginning January 1, 2016, funding maintenance and operations of the Police Department.
4. **L15-163 - Richland Parish, Mangham Fire Protection District No. 4** - \$100 parcel fee, 25 years, 2017-2041, (1) acquiring, constructing, maintaining and operating fire protection facilities and equipment, including paying the cost of obtaining water for fire protection purposes and salaries of firemen and (2) funding into bonds.
5. **L15-148 - Washington Parish, City of Bogalusa** - 2.75 mills tax, 10 years, 2016-2025 paying the costs of providing retirement and pension benefits for the City of Bogalusa Retirement System.

17. **L15-160 - Rapides Parish, Waterworks District No. 3 -** Not exceeding \$3,700,000 Water Revenue Refunding Bonds, not exceeding 5%, mature no later than August 1, 2030, refunding Water Revenue Bonds, Series 2005.

28. **S15-029 - Louisiana Housing Corporation (Iberville On-Site Phase IV Project)** - Not exceeding \$22,000,000 Multifamily Housing Revenue Bonds (Volume Cap), in a single series, not exceeding 12%, not exceeding 40 years, acquisition, construction, rehabilitation, and equipping of a 164-unit multifamily housing facility in Orleans Parish.
