28. **L16-403 - East Baton Rouge Parish, Metropolitan Council of the Parish of East Baton Rouge and City of Baton Rouge, Baton Rouge North Economic Development District** - 2% Hotel Occupancy Tax, to be levied in perpetuity, beginning February 1, 2017, any lawful purpose.
29. **L16-366 - East Baton Rouge Parish, Metropolitan Council of the Parish of East Baton Rouge and City of Baton Rouge, Brownsfield Fire Protection District No. 3** - 5.0 mills tax, 10 years, 2019-2028, (1) development, operation, and maintenance of the fire protection facilities and (2) paying the costs of obtaining water for fire protection purposes, including charges for fire hydrant rentals and service.
30. **L16-364 - East Baton Rouge Parish, Metropolitan Council of the Parish of East Baton Rouge and City of Baton Rouge, Chaneyville Fire Protection District No. 7** - 10.0 mills tax, 10 years, 2019-2028, (1) development, operation and maintenance of the fire protection facilities and (2) obtaining water for fire protection purposes, including charges for fire hydrant rentals and service.
31. **L16-365 - East Baton Rouge Parish, Metropolitan Council of the Parish of East Baton Rouge and City of Baton Rouge, Chaneyville Fire Protection District No. 7** - 10.0 mills tax, 10 years, 2017-2026, (1) development, operation and maintenance of the fire protection facilities and (2) obtaining water for fire protection purposes, including charges for fire hydrant rentals and service.
32. **L16-362 - East Baton Rouge Parish, Metropolitan Council of the Parish of East Baton Rouge and City of Baton Rouge, Consolidated Road Lighting District No. 1** - 7.0 mills tax, 10 years, 2019-2028, providing, maintaining, and operating electric lights on the streets, roads, highways, alleys and public places.
33. **L16-363 - East Baton Rouge Parish, Metropolitan Council of the Parish of East Baton Rouge and City of Baton Rouge, Pride Fire Protection District No. 8** - 10.0 mills tax, to be levied in perpetuity, beginning in 2018, (1) development, operation and maintenance of fire protection facilities and (2) paying the costs of obtaining water for fire protection purposes, including charges for fire hydrant rentals and service.

34. **L16-429 - East Baton Rouge Parish, Parkwood Terrace Crime Prevention and Neighborhood Improvement District** - \$100 parcel fee, 10 years, 2018-2027, to increase once after five years provided said fee to not exceed \$150, (1) aid in crime prevention and (2) funding beautification and improvements
35. **L16-331 - East Baton Rouge Parish, Wedgewood Crime Prevention and Improvement District** - \$95 residential parcel fee and \$250 commercial parcel fee, 10 years, 2017-2026, to increase twice after three years provided said fee to not exceed \$150 residential and \$400 commercial, (1) aid in crime prevention and add to the security, (2) increase the presence of law enforcement personnel, (3) increase security patrols, (4) beautify and improve the common areas, and (5) provide for overall betterment.
36. **L16-349 - Franklin Parish, City of Winnsboro** - 0.5% sales tax, 10 years, beginning July 1, 2017, (1) improvement, maintenance, and/or repair of public streets, including related drainage and utilities and (2) acquisition, maintenance, and repair of equipment and (3) funding into bonds.
37. **L16-393 - Franklin Parish, Fire Protection District No. 3** - 15.0 mills tax, 10 years, 2018-2027, (1) acquiring, constructing, improving, maintaining and operating fire protection facilities and equipment, including purchasing fire trucks and other fire fighting equipment and (2) paying the cost of obtaining water for fire protection purposes.
38. **L16-389 - Franklin Parish, Fire Protection District No. 5** - 10.0 mills tax, 10 years, 2017-2026, (1) acquiring, constructing, improving, maintaining, and operating fire protection facilities and equipment and (2) paying the cost of obtaining water for fire protection purposes.
39. **L16-425 - Grant Parish Police Jury** - (1) 2.07 mills tax, 10 years, 2018-2027, maintaining a Health Unit and other miscellaneous expenses incurred in the operation; (2) 3.22 mills tax, 10 years, 2018-2027, maintaining the Courthouse, all Courthouse Annex Buildings and Jail; (3) 8.61 mills tax, 10 years, 2018-2027, constructing, improving, repairing, and maintaining public roads and bridges.
40. **L16-432 - Jackson Parish, Town of Eros** - 1% sales tax, 10 years, beginning December 16, 2016, (1) any lawful public purpose and (2) funding into bonds.
41. **L16-395 - Jefferson Parish School Board, School District No. 1** - 4.0 mills tax, 10 years, 2018-2027, to be dedicated as follows: (1) 1.0 mill, continuation and expansion of the Technology Department to include (a) additional personnel and (b) acquiring and maintaining equipment and supplies for educational and instructional purposes; (2) 2.0 mills, capital projects and (3) 1.0 mill, (a) maintaining and improving existing public school houses and buildings, including roof repair and replacement, repair and (b) replacement of heating and air conditioning systems.
42. **L16-326 - Lafayette Parish, City of Carencro** - 1% sales tax, to be levied in perpetuity, beginning April 1, 2017, (1) constructing, operating, improving and maintaining the sewerage system; (2) providing facilities for and operational support of police and fire protection and (3) funding into bonds.
43. **L16-409 - Lafourche Parish, Fire Protection District No. 4** - 6.02 mills tax, 10 years, 2017-2026, acquiring, constructing, improving, maintaining and/or operating fire protection facilities and equipment, including purchase of fire trucks.

53. **L16-381 - Ouachita Parish Police Jury** - 9.2 mills tax, 5 years, 2017-2021, (1) first for satisfying the statutory obligations with respect to the parish jail "Ouachita Correctional Center" and the maintenance of the prisoners incarcerated and (2) the balance to be applied to expenses incurred by the Sheriff in connection with the operation of the correctional center.
54. **L16-317 - Rapides Parish Police Jury, Road District No. 5A** - 48.24 mills tax, 10 years, 2018-2027, constructing, maintaining, and keeping in repair public roads, highway and bridges.
55. **L16-339 - Rapides Parish, Town of Boyce** - 1% sales tax, to be levied in perpetuity, beginning April 1, 2017, general municipal purposes.
56. **L16-370 - St. Charles Parish Council** - (1) 3.02 mills tax, 10 years, 2018-2027, constructing, improving, maintaining and operating recreation facilities and programs; (2) 1.0 mills tax, 10 years, 2018-2027, constructing, improving, maintaining and operating facilities and programs for the elderly through the St. Charles Council on Aging, Inc.
57. **L16-386 - St. Helena Parish Law Enforcement District** - 10.0 mills tax, 10 years, 2017-2026, providing additional funding.
58. **L16-335 - St. Helena Parish Police Jury** - 3.55 mills tax, 10 years, 2019-2028, (1) acquire, improve, maintain, operate, and support Parish Senior Citizens' Centers and (2) provide funding for Parish Senior Citizens' programs, services, and facilities provided, or operated by, the St. Helena Parish Council on Aging.
59. **L16-424 - St. James Parish Law Enforcement District** - 12.5 mills tax, 10 years, 2017-2026, providing additional funding.

60. **L16-356 - St. James Parish School Board, School District No. 1** - (1) 9.0 mills tax, 10 years, 2017-2026, additional support to the public schools dedicated to salary increases for teachers and all employees of the school system; (2) 3.0 mills tax, 10 years, 2017-2026, additional support to the public schools dedicated to salary increases for teachers and all employees of the school system directly involved with providing early childhood development (4 years olds).
61. **L16-379 - St. John the Baptist Parish Council** - 1.0 mills tax, rededicating proceeds collected and unexpended, constructing, renovating or improving facilities for housing and detaining juvenile offenders and/or various personnel associated with juvenile justice services, including providing necessary furnishings, equipment and transportation, paying costs associated with juvenile justice programs including prevention programs.
62. **L16-355 - St. John the Baptist Parish School Board** - $\frac{1}{4}\%$ sales tax, to be levied in perpetuity, beginning July 1, 2017, (1) 50% for payment of salaries and benefits for all permanent school employees and (2) 50% for maintaining and repairing all school buildings.
63. **L16-394 - St. Martin Parish Council** - Not exceeding \$25,000,000 General Obligation Bonds, not exceeding 7%, not exceeding 20 years, (1) \$20,000,000 for acquiring, constructing and improving drains, canals, pumps, pumping plants, dykes, levees and other drainage works and (2) \$5,000,000 for acquiring, constructing, improving and equipping parks, playgrounds, recreation centers and other recreational facilities.
64. **L16-427 - St. Martin Parish Council, Road District No. 1, Sub-Road District No. 3** - 5.09 mills tax, 10 years, 2017-2026, constructing and improving public roads and highways, or for the maintenance.
65. **L16-388 - St. Martin Parish, Water and Sewer Commission No. 1** - 7.80 mills tax, 10 years, 2017-2026, acquiring, constructing, improving, maintaining, and operating sewers and sewerage disposal works, including the payment of principal and interest on any debt obligations previously issued by Sewerage District No. 1 or hereafter issued by the Commission to construct, acquire and improve sewers and sewerage disposal works.
66. **L16-338 - St. Mary Parish, Consolidated Gravity Drainage District No. 1** - 7.81 mills tax, 10 years, 2017-2026, acquiring, constructing, maintaining, and operating gravity drainage works.
67. **L16-426 - St. Mary Parish, Water and Sewer Commission No. 4** - 15.31 mills tax, 10 years, 2017-2026, operating, maintaining, improving and extending the waterworks plant and system and sewer and sewerage treatment or disposal facilities.
68. **L16-369 - St. Tammany Parish, Northshore Harbor Center District** - 3.0 mills tax, 10 years, 2017-2026, development, maintenance, operation, and administration of the facilities.
69. **L16-354 - St. Tammany Parish, Recreation District No. 12** - 10.0 mills tax, 10 years, 2018-2027, acquiring, constructing, improving, maintaining or operating parks playgrounds, recreation centers and other recreational facilities, together with the necessary furnishings and equipment.

73. **L16-421 - Tensas Parish, Town of Waterproof** - 14.0 mills tax, 10 years, 2017-2026, any lawful corporate purpose.

76. **L16-411 - Vernon Parish Police Jury** - Not exceeding \$1,550,000 General Obligation Bonds, not exceeding 6%, not exceeding 15 years, constructing, improving, equipping and furnishing public buildings and facilities.
77. **L16-353 - Webster Parish, Fire Protection District No. 3** - 15.46 mills tax, 10 years, 2018-2027, acquiring, constructing, improving, maintaining and operating fire protection facilities and equipment, including paying the cost of obtaining water for fire protection purposes.
