3. **L17-097 - Avoyelles Parish Police Jury, Road District No. 2** - Not exceeding \$1,000,000 Limited Tax Certificates of Indebtedness, Series 2017, not exceeding 2.55%, mature no later than March 1, 2027, (1) constructing and improving streets, roads, highways and bridges, including ditches and drainage, (2) acquiring machinery and equipment, and (3) constructing a material equipment center.
4. **L17-099 - Bossier Parish, Northeast Bossier Fire Protection District No. 5** - Not exceeding \$500,000 Limited Tax Certificates of Indebtedness, Series 2017, not exceeding 3.15%, mature no later than March 1, 2023, acquiring, constructing and improving fire protection and emergency medical service facilities, vehicles and equipment, including movable property.
5. **L17-098 - East Baton Rouge Parish, Fire Protection District No. 6** - Not exceeding \$355,125 Revenue Anticipation Notes (CDL Program), not exceeding 4%, not exceeding 5 years, current operations.

6. **L17-101 - St. Charles Parish Council (DEQ Project)** - Not exceeding \$8,000,000 Taxable Limited Tax Bonds, not exceeding 0.95%, mature no later than March 1, 2039, acquiring, constructing and improving wastewater facilities and systems, including those owned and operated by Consolidated Waterworks and Wastewater District No. 1.
7. **L17-102 - West Baton Rouge Parish, Town of Addis (DEQ Project)** - Not exceeding \$3,000,000 Taxable Sewer Revenue Bonds, in one or more series, not exceeding 0.95%, not exceeding 22 years, constructing and acquiring additions, extensions and improvements to the sewage collection and disposal system, including all necessary land, equipment and furnishings and all engineering, legal and other incidental costs and fees.
