- b. **Louisiana Department of Revenue**  
Request to open a new ZBA bank accounts at JPMorgan Chase, Baton Rouge to be utilized for tax collections from external collections agencies. (ECA's)
  - c. **Louisiana Department of Health, Northeast Delta Human Services Authority**  
Request to open a new checking bank account at Origin Bank, Monroe, Louisiana to set up capabilities to accept debit and credit cards. This will minimize monthly charges of \$71.50 per account for three accounts by consolidating it to just one bank account. Origin Bank has a branch in three of the clinics' cities.
  - d. **Louisiana Department of Justice**  
Request to open a new bank account to collect on-line payments for registrations, charities, athletic agents, professional solicitors, going out of business etc.
  - e. **Louisiana Public Service Commission**  
Request to repurpose an authorized existing bank account at JPMC, Baton Rouge, La. to include acceptance of credit card payments. Currently the account accepts wires and ACH transactions from the Commission's Do Not Call Telephonic Solicitation Fund.
  - f. **Special School District**  
Request to change the name on the account to Special School District, due to the merge of Louisiana School for the Deaf and Visually Impaired and Special School District per HP 253.
  - g. **Louisiana Department of Health – Office of Management and Finance**  
Request to reactivate and repurpose lockbox 62949 to accept deposits and documentation for the Health Information Technology for Economic and Clinical Health program. Based on current information there is 2.6 million in funds that is due to the Louisiana Department of Health from various providers and hospitals.
