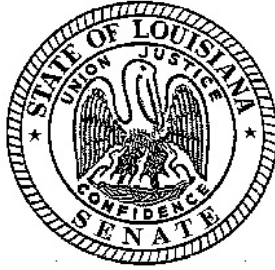

SB 146	TALBOT	HEALTH/ACC INSURANCE Provides for health insurance coverage of cancer treatments. (8/1/22)
SB 154	TALBOT	HEALTH/ACC INSURANCE Provides for health insurance coverage of genetic testing for critically ill infants with no diagnosis. (1/1/23)
SB 168	ABRAHAM	INSURANCE POLICIES Provides relative to commercial insurance. (1/1/23)
SB 209	STINE	INSURERS Authorizes the commissioner of insurance to order certain penalties to persons engaging in an unfair method of competition or an unfair or deceptive act or practice. (8/1/22)
SB 276	TALBOT	HEALTH/ACC INSURANCE Provides the original intent of the Louisiana Legislature authorized contracts between health insurers and healthcare providers allowed for benefits to be available to its affiliates. (8/1/22)
SB 366	HARRIS	INSURERS Prohibits certain health insurance cost-sharing practices. (gov sig)
