3. **L24-340 - Acadia Parish Police Jury, Sales Tax District No. 2** - 1% sales tax, 15 years, beginning April 1, 2027, repairing, constructing, improving and maintaining roads and bridges in the unincorporated areas of the Parish, including incidental drainage in connection therewith and acquiring equipment.
4. **L24-367 - Allen Parish, Elizabeth Recreation District No. 3** - 11.28 mills tax, 10 years, 2026-2035, acquiring, constructing, improving, maintaining, and/or operating recreational facilities.
5. **L24-355 - Ascension Parish Council** - Amend Article IV, Section 4-04(A) of the Home Rule Charter relating to the salary of Governing Authority members.
6. **L24-381 - Assumption Parish, Bayou Pierre Part North Gravity Drainage District** - \$50 parcel fee, 10 years, 2025-2034, constructing and maintaining levees, levee drainage, flood protection, hurricane flood protection, and all purposes incidental thereto, including compensation for the exercise of permanent or temporary servitudes, debt obligations and funding into bonds.
7. **L24-358 - Bossier Parish, City of Bossier City** - **(1)** Amend and restate the City Charter, in entirety, as set forth in the revisions prepared and submitted by the Citizens Charter Review Commission as advertised in the Bossier Press Tribune on January 15, January 22, January 29, and February 5, 2025; **(2)** Amend Section 3.01(b) of the existing City Charter or the amended and restated City Charter set forth in Proposition No. 1, if approved, relative to term limits for City Council members; **(3)** Amend Section 4.01 of the existing City Charter or the amended and restated City Charter set forth in Proposition No. 1, if approved, relative to term limits for Mayor.
8. **L24-334 - Bossier Parish, Northeast Bossier Fire Protection District No. 5** - 27.50 mills tax, 10 years, 2025-2034, acquiring, constructing, improving, maintaining and/or operating fire protection and emergency medical service facilities, vehicles and equipment, including both movable and immovable property to be used directly or indirectly to provide fire protection or emergency medical service, including the costs of obtaining water for fire protection purposes and charges for fire hydrant rentals and service.
9. **L24-346 - Bossier Parish, Town of Benton** - 4.90 mills tax, 10 years, 2026-2035, maintaining streets.
10. **L24-331 - Caddo Parish, Fire District No. 4** - 1% sales tax, to be levied in perpetuity, beginning July 1, 2025, any lawful purpose, including but not limited to acquiring, constructing, improving, operating and maintaining fire protection facilities and purchasing fire trucks and other fire fighting equipment.
11. **L24-330 - Caddo Parish, Fire District No. 6** - 1% sales tax, to be levied in perpetuity, beginning July 1, 2025, any lawful purpose, including but not limited to acquiring, constructing, improving, operating and maintaining fire protection facilities and purchasing fire trucks and other fire fighting equipment.
12. **L24-336 - Caddo Parish School Board, Parishwide School District** - **(1)** 19.49 mills tax, 10 years, 2027-2036, salaries and benefits for teachers and other personnel; **(2)** 4.97 mills tax, 10 years, 2027-2036, renovation, repair and improvement of existing public school buildings and facilities; **(3)** 1.21 mills tax, 10 years, 2027-2036, constructing, acquiring, renovating, improving, maintaining and/or operating computers, software and peripheral equipment, facilities and technological programs at public schools.

13. **L24-333 - Claiborne Parish, Fire Protection District No. 5** - 20.0 mills tax, 10 years, 2025-2034, acquiring, constructing, improving, operating and maintaining fire protection and emergency medical service facilities and equipment, including paying the cost of obtaining water.
14. **L24-342 - Claiborne Parish School Board, School District** - (1) 5.22 mills tax, 10 years, 2026-2035, giving additional support to the public schools; (2) 5.22 mills tax, 10 years, 2026-2035, constructing, improving and maintaining school houses and other school property.
15. **L24-369 - East Baton Rouge Parish, City of St. George** - Adopt a Home Rule Charter for the City of St. George, prepared and submitted by the appointed Home Rule Charter Commission.
16. **L24-335 - East Baton Rouge Parish, Wedgewood Crime Prevention and Improvement District** - \$95 residential parcel fee and \$250 commercial parcel fee, 10 years, 2027-2036, subject to increase provided said fee to not exceed \$150 residential and \$400 commercial, aid in crime prevention and add security, increase the presence of law enforcement personnel, increase security patrols, beautify and improve the common areas, and provide for overall betterment.
17. **L24-353 - Iberia Parish, City of New Iberia** - ¼% sales tax, to be levied in perpetuity, beginning July 1, 2025, salaries and benefits of personnel for the fire department, including an initial raise in the first full fiscal year following the effective date of the tax.
18. **L24-354 - Iberia Parish Council** - 4.50 mills tax, 10 years, 2025-2034, operating and maintaining public libraries.
19. **L24-341 - Iberia Parish, Fire Protection District No. 1** - 3.5 mills tax, 10 years, 2025-2034, acquiring, constructing, improving, maintaining and operating fire protection facilities and equipment, including obtaining water for fire protection purposes and all purposes incidental thereto.
20. **L24-345 - Jackson Parish Law Enforcement District** - 9.23 mills tax, 10 years, 2026-2035, providing additional funding.
21. **L24-329 - Jefferson Davis Parish, Gravity Drainage District No. 6** - 5.73 mills tax, 10 years, 2026-2035, maintaining, constructing and improving drainage works.
22. **L24-347 - Jefferson Parish, Southeast Louisiana Flood Protection Authority - West, West Jefferson Levee District** - 4.75 mills tax, 10 years, 2028-2037, constructing, raising, armoring and maintaining levees and repair, rehabilitation and replacement of capital projects for purposes of flood and hurricane protection, including the Bayou Segnette Complex, Harvey Sector Gate Complex and the District's share of the West Closure Complex, including payments of debt obligations incurred for any of the above capital projects.
23. **L24-365 - Lafayette Parish Council** - (1) 4.47 mills tax, 10 years, 2027-2036, constructing, improving and maintaining roads and bridges; (2) 3.81 mills tax, 10 years, 2026-2035, 1.24 mills for constructing, acquiring, improving and maintaining drains and drainage facilities, 0.422 mills for fire protection and all costs affiliated thereto, 0.078 mills for constructing, improving, and maintaining roads and bridges and 2.07 mills for constructing, improving, maintaining, operating and supporting public health units, mosquito and other arthropod abatement and control facilities and programs, and animal control facilities and programs, acquiring furnishings and equipment, and paying mandated expenses of the coroner.
24. **L24-359 - Lafourche and Terrebonne Parishes, Bayou Blue Fire Protection District** - 20.0 mills tax, 10 years, 2027-2036, acquiring, constructing, improving, maintaining and operating facilities and equipment to provide fire protection and emergency medical services and obtaining water for fire protection purposes, including fire hydrants rentals and service.
25. **L24-357 - Lafourche Parish, City of Thibodaux** - 5.0 mills tax, 10 years, 2027-2036, acquiring, constructing, improving and maintaining fire protection facilities and emergency rescue service facilities, vehicles and equipment, including both movable and immovable property.
26. **L24-338 - Lafourche Parish, Fire Protection District No. 4** - 6.02 mills tax, 10 years, 2027-2036, acquiring, constructing, improving, maintaining and/or operating fire protection facilities and equipment, including the purchase of fire trucks.

27. **L24-368 - Orleans Parish, City of New Orleans, Lakeview Crime Prevention District** - Not exceeding \$150 parcel fee, 10 years, 2027-2036, aiding in crime prevention and addition to the security of residents.

30. **L24-372 - Ouachita Parish Police Jury** - (1) 7.64 mills tax, 10 years, 2026-2035, equipment, supplies, maintenance, operation, construction, acquisition, improvement, renovation and support of the Parish Library and its branches; (2) 2.90 mills tax, 10 years, 2026-2035, improving, maintaining, operating and equipping the Parish Juvenile Detention Center.
31. **L24-374 - Plaquemines Parish Council** - Amend the Home Rule Charter to create the Plaquemines Port Commission as the governing authority of the Plaquemines Port, Harbor and Terminal District in lieu of the Plaquemines Parish Council and provide for other matters related thereto.
32. **L24-351 - Red River Parish, Parishwide Fire Protection District** - 4.66 mills tax, 10 years, 2026-2035, maintaining and operating fire protection facilities and paying the cost of obtaining water for fire protection purposes, including charges for fire hydrant rentals and service.
33. **L24-339 - Red River Parish Police Jury** - 1.21 mills tax, 10 years, 2026-2035, acquire, construct, maintain and operate Parish Senior Citizens' Centers and provide funding for Parish Senior Citizens' Programs, operated by the Red River Parish Council on Aging.
34. **L24-380 - St. James Parish Law Enforcement District** - 12.5 mills tax, 10 years, 2027-2036, providing additional funding.
35. **L24-343 - St. Landry Parish, Fire Protection District No. 3** - 10.36 mills tax, 10 years, 2026-2035, constructing, maintaining and operating fire protection facilities and obtaining water for fire protection purposes.
36. **L24-362 - St. Tammany Parish Council** - 4.35 mills tax, 15 years, 2025-2039, constructing, acquiring, improving, maintaining and/or operating public library facilities, furnishings and equipment, and otherwise supporting the public library system.
37. **L24-363 - St. Tammany Parish Council, Road Lighting District No. 10** - \$80 service charge, 10 years, 2025-2034, paying utility charges for road lighting and maintaining and operating road lighting facilities and equipment.

40. **L24-375 - Tangipahoa Parish Law Enforcement District** - ¾% sales tax, to be levied in perpetuity, beginning July 1, 2025, funding school resource officer positions at all elementary and secondary schools, funding additional law enforcement positions, providing equipment for personnel and any lawful purpose.
41. **L24-350 - Tangipahoa Parish, Mosquito Abatement District No. 1** - 4.98 mills tax, 10 years, 2027-2036, acquiring, purchasing, maintaining and operating machinery, facilities, equipment and materials necessary or useful in the eradication, abatement or control of mosquitoes and other arthropods of public health importance.

42. **L24-319 - Terrebonne Parish, Recreation District No. 11** - 10.0 mills tax, 10 years, 2026-2035, constructing, improving, maintaining and operating recreational facilities, including purchase of equipment.
43. **L24-332 - Union Parish, Spencer-West Sterlington Fire Protection District** - \$40 service charge, 10 years, 2025-2034, acquiring, constructing, improving, maintaining or operating fire protection facilities, vehicles and equipment, including both movable and immovable property.
