1. Call to order and roll call.
2. Approval of the minutes of the November 12, 2025 and November 20, 2025 meetings.

LOCAL GOVERNMENTAL UNITS - ELECTIONS (MAY 16, 2026)

3. **L25-285 - Bienville Parish, Town of Ringgold** - 10.0 mills tax, 20 years, 2026-2045, improving, maintaining, operating and supporting the sewerage system, sewer treatment facilities, solid waste landfill, waterworks system, and drainage facilities, including acquiring and purchasing equipment and fixtures, and any lawful purposes.
4. **L25-310 - Calcasieu Parish, City of Lake Charles** - (1) Not exceeding 2.31 mills tax, 10 years, 2027-2036, maintenance of public buildings, streets and bridges; (2) Not exceeding 1.70 mills tax, 10 years, 2027-2036, maintenance of playgrounds and recreation centers and equipment; (3) Not exceeding 5.27 mills tax, 10 years, 2027-2036, maintaining pay increases and starting salaries previously authorized for employees of the Police, Fire, Public Works, and other departments and maintenance of a Police Department three platoon system.
5. **L25-317 - Calcasieu Parish School Board, School District No. 25** - Not exceeding \$20,000,000 General Obligation Bonds, not exceeding 7%, not exceeding 25 years, acquiring and/or improving lands for buildings and playgrounds, purchasing, erecting, enlarging and/or improving school buildings and other related facilities and necessary equipment and furnishings therefor.
6. **L25-318 - Calcasieu Parish School Board, School District No. 34** - Not exceeding \$88,000,000 General Obligation Bonds, not exceeding 7%, not exceeding 25 years, acquiring and/or improving lands for buildings and playgrounds, purchasing, erecting, enlarging and/or improving school buildings and other related facilities and necessary equipment and furnishings therefor.
7. **L25-316 - Calcasieu Parish, Town of Iowa** - 1% sales tax, to be levied in perpetuity, beginning July 1, 2027, maintenance and construction of streets, sidewalks and street lighting, maintenance and construction of sewerage treatment facilities, systems, pumps and sewer lines, and general administrative and general fund needs.
8. **L25-315 - Calcasieu Parish, Waterworks District No. 14, Ward 5** - 15.98 mills tax, 10 years, 2027-2036, maintaining and operating the waterworks system, equipment and facilities.
9. **L25-313 - Cameron Parish, Ambulance Service District No. 2** - 14.0 mills tax, 10 years, 2027-2036, providing ambulance service.
10. **L25-314 - Cameron Parish School Board** - (1) 10.5 mills tax, 10 years, 2027-2036, providing additional support to the maintenance, improvement and operations of the public elementary and secondary school system; (2) 10.5 mills tax, 10 years, 2027-2036, providing additional support to the maintenance, improvement and operations of the public elementary and secondary school system.
11. **L25-258 - Claiborne Parish, Town of Homer** - (1) 1% sales tax, rededicate proceeds heretofore and hereafter, in perpetuity, 60% constructing, paving, resurfacing, improving, maintaining, and/or operating streets and 40% any lawful purpose; (2) 1% sales tax, rededicate proceeds heretofore and hereafter, in perpetuity, 70% improving, maintaining, and operating public works, including streets, drainage, sewer, waterworks, garbage, police, public buildings, fire, recreation and purchasing and acquiring the necessary land, equipment and furnishings, and funding into bonds and 30% any lawful purpose; (3) 1% sales tax, rededicate proceeds heretofore and hereafter, in perpetuity, primarily for regular residential garbage collection and funding into bonds, and remaining proceeds for any lawful purpose.

12. **L25-311 - East Feliciana Parish School Board** - (1) 1% sales tax, 10 years, beginning January 1, 2027, 91% of proceeds for salaries and benefits for all employees of the school system and 9% of proceeds for maintaining and operating public schools; (2) **School District No. 1** - 17.0 mills tax, 10 years, 2027-2036, salaries and benefits for teachers and other employees; (3) **School District No. 1** - 1% sales tax, 10 years, beginning July 1, 2027, a minimum of one-half of proceeds for paying teachers' salaries and benefits and remaining proceeds for constructing, supporting, maintaining and operating public schools.
13. **L25-283 - Franklin Parish, Fire Protection District No. 3** - 15.0 mills tax, 10 years, 2028-2037, acquiring, constructing, improving, maintaining and operating fire protection facilities and equipment, including purchasing fire trucks and other fire fighting equipment and paying the cost of obtaining water for fire protection purposes.
14. **L25-282 - Franklin Parish, Fire Protection District No. 5** - 10.0 mills tax, 10 years, 2027-2036, acquiring, constructing, improving, maintaining and operating fire protection facilities and equipment and paying the cost of obtaining water for fire protection purposes.
15. **L25-293 - Franklin Parish Police Jury** - (1) 11.17 mills tax, 10 years, 2028-2037, construction, maintenance and operation of and purchase of equipment for the drainage system; (2) 4.07 mills tax, 10 years, 2028-2037, operation and maintenance of the Parish Courthouse; (3) 8.14 mills tax, 10 years, 2028-2037, maintaining, operating and purchasing equipment; (4) 4.27 mills tax, 10 years, 2029-2038, purchasing, operating and maintaining road equipment and salary adjustments for Parish employees; (5) ½% sales tax, 10 years, beginning December 1, 2028, solid waste collection and disposal.
16. **L25-275 - Lafourche Parish Council** - 2.03 mills tax, 10 years, 2028-2037, funding senior citizens' programs and services administered by the Lafourche Council on Aging, Inc./Area Agency on Aging, and acquiring, constructing, improving and maintaining building and facilities for their use.
17. **L25-308 - Ouachita Parish, Monroe City School Board, City of Monroe Special School District** - (1) 14.41 mills tax, 10 years, 2027-2036, maintaining and operating the city schools; (2) 6.15 mills tax, 10 years, 2027-2036, giving and providing additional aid and support to the city schools, provided proceeds will not be for payment of salaries of professional personnel.
18. **L25-304 - Ouachita Parish Police Jury, Consolidated Road Lighting District No. 52** - \$75.00 service charge, plus a collection charge of \$3.75, 10 years, 2026-2035, paying utility charges, maintenance and operation costs for road lighting facilities and equipment.
19. **L25-284 - Rapides Parish Police Jury** - (1) **Fire Protection District No. 2, Service Area No. 1** - 25.0 mills tax, 10 years, 2026-2035, acquiring, constructing, improving, maintaining, and operating fire protection and emergency medical service facilities, vehicles and equipment; (2) **Fire Protection District No. 2** - 20.0 mills tax, 10 years 2026-2035, acquiring, constructing, improving, maintaining, and operating fire protection and emergency medical service facilities, vehicles and equipment.
20. **L25-305 - Richland Parish, Town of Mangham** - 1% sales tax, 10 years, beginning January 1, 2027, any lawful purpose.
21. **L25-309 - Tangipahoa Parish Council** - (1) Amend Article II, Section 2-01(A) of the Home Rule Charter, relative to term limits for Parish Council Members; (2) Amend Article III, Section 3-02 of the Home Rule Charter, relative to term limits of the Parish President.

LOCAL GOVERNMENTAL UNITS - ELECTIONS (JUNE 27, 2026)

22. **L25-250 - St. Landry Parish, Town of Sunset** - 10.0 mills tax, 20 years, 2026-2045, maintaining, operating, and improving fire protection services, purchasing fire trucks and other fire fighting equipment and emergency rescue equipment, obtaining water, acquiring fire protection equipment and facilities, including specialized rescue tools and life saving equipment, and funding salaries and benefits of full time, part-time, and volunteer firefighters.

LOCAL POLITICAL SUBDIVISIONS - CASH FLOW BORROWINGS

23. **L25-319 - Natchitoches Parish, Hospital Service District** - Not exceeding \$7,500,000 Revenue Anticipation Notes, not exceeding 6%, mature no later than September 30, 2026, paying current expenses.

LOCAL POLITICAL SUBDIVISIONS - LOANS

24. **L25-306 - Bossier Parish Police Jury, Consolidated Waterworks/Sewerage District No. 1 (LDH Program)** - Not exceeding \$6,320,000 Loan, non-interest bearing, not exceeding 10 years, funding additions, acquisitions, repairs and/or expansions to works of the District.
25. **L25-312 - Ouachita Parish Police Jury** - Not exceeding \$2,700,000 Limited Tax Revenue Bonds, not exceeding 6%, mature no later than March 1, 2033, constructing, equipping and operating a new animal shelter.

LOCAL POLITICAL SUBDIVISIONS - BONDS - FINAL APPROVAL

26. **L25-294 - Morehouse Parish School Board (Beekman Charter School Project)** - Not exceeding \$5,900,000 Revenue Bonds, not exceeding 8%, not exceeding 25 years, constructing a junior high school building and related facilities, furnishings, and equipment.
27. **L25-307 - St. Mary Parish, City of Morgan City** - Not exceeding \$3,100,000 Limited Tax Bonds, not exceeding 6%, mature no later than March 1, 2038, demolition, rehabilitation, repair, reconstruction, renovation, restoration and improvement of properties and facilities resulting from or related to Hurricane Francine, including purchasing materials, furnishings, fixtures and equipment.

POLITICAL SUBDIVISIONS - BONDS

28. **S25-038 - Louisiana Community Development Authority (Lake Charles Rebound Project)** - Not exceeding \$145,000,000 Revenue Bonds, not exceeding 6%, not exceeding 30 years, constructing, acquiring, operating and maintaining projects, works, improvements, and equipment, and funding a debt service reserve fund, if necessary.
