
SENATE FLOOR AMENDMENTS

2016 Regular Session

Amendments proposed by Senator Martiny to Engrossed Senate Bill No. 424 by Senator Martiny

1 AMENDMENT NO. 1

2 On page 2, line 6, after "**offense**" insert "**as defined in R.S. 15:541, a person serving a life**
3 **sentence for first degree murder as defined in R.S. 14:30,**"

4 AMENDMENT NO. 2

5 On page 2, delete line 11, and insert "**14:2(B) other than first degree murder as defined**
6 **in R.S. 14:30, or is convicted a second time and the second conviction is a crime of**
7 **violence as defined in R.S. 14:2(B) other than first degree murder as defined in R.S.**
8 **14:30, provided the first conviction**"

9 AMENDMENT NO. 3

10 On page 2, at the end of line 12, insert "**The provisions of this Paragraph shall not apply**
11 **to a person who has been convicted of a sex offense as defined in R.S. 15:541, regardless**
12 **of whether it is a first or subsequent conviction.**"

13 AMENDMENT NO. 4

14 On page 2, delete lines 20 through 25, and insert the following:

15 (a) The offender has not been convicted of a ~~crime of violence as~~
16 ~~defined in R.S. 14:2(B) or~~ a sex offense as defined in R.S. 15:541; or
17 convicted of an offense which would constitute a ~~crime of violence as~~
18 ~~defined in R.S. 14:2(B) or~~ a sex offense as defined in R.S. 15:541, **but has**
19 **been convicted a first time of a crime of violence as defined in R.S.**
20 **14:2(B) other than first degree murder as defined in R.S. 14:30, or**
21 **convicted a second time of a crime of violence as defined in R.S. 14:2(B)**
22 **other than first degree murder as defined in R.S. 14:30, provided the**
23 **first conviction was not a crime of violence as defined in R.S. 15:541,**
24 regardless of the date of conviction."

25 AMENDMENT NO. 5

26 On page 3, line 8, after "violence" insert "**as defined in R.S. 14:2(B) other than first**
27 **degree murder as defined in R.S. 14:30, or a sex offense as defined in R.S. 15:541,**"

28 AMENDMENT NO. 6

29 On page 3, line 18, after "parole" delete the remainder of the line and delete lines 19 through
30 22 and insert the following:

31 ", who has not been convicted of a ~~crime of violence as defined by R.S.~~
32 ~~14:2(B),~~ a sex offense as defined by R.S. 15:541, ~~or~~ an offense, regardless of
33 the date of conviction, which would constitute a ~~crime of violence as defined~~
34 ~~by R.S. 14:2(B) or~~ a sex offense as defined by R.S. 15:541, **or first degree**
35 **murder as defined in R.S. 14:30,** shall be eligible for parole consideration
36 as follows:"
