A RESOLUTION

2	To commend Micah Samari Minter upon achieving the rank of Eagle Scout.
3	WHEREAS, it is appropriate to commend and celebrate the accomplishments of
4	Micah Samari Minter of Boy Scouts of America Troop 301 on the memorable and historic
5	occasion of his attainment to the prestigious rank of Eagle Scout; and
6	WHEREAS, the purpose of Boy Scouts of America, founded on February 8, 1910,
7	and chartered by the United States Congress in 1916, is to provide an educational program
8	for boys and young adults to build character, to train in the responsibilities of participating
9	citizenship, and to develop personal fitness; and
10	WHEREAS, to earn the rank of Eagle Scout, the highest rank in Scouting, a Boy
11	Scout must fulfill all the requirements of leadership, service, and outdoor skills; an Eagle
12	Scout must earn twenty-one merit badges which signify the mastery of Scouting skills,
13	including Citizenship in the Community, Citizenship in the Nation, and Citizenship in the
14	World; and
15	WHEREAS, in addition to the merit badges Micah Samari Minter has earned in his
16	seven years of Scouting, Micah helped to remodel the Galilee Baptist Church pantry, and
17	also singlehandedly conducted a nonperishable food drive where he collected enough items
18	to completely fill the pantry; and
19	WHEREAS, only a small percentage of Boy Scouts attain the Eagle Scout rank; it
20	takes a uniquely motivated man to achieve the five important responsibilities of an Eagle

1 Scout, which are honor, loyalty, courage, cheer, and service to God and country, and Micah

- WHEREAS, presented with his Eagle Scout badge, Micah Samari Minter joins the
- 4 ranks of such esteemed and respected Eagle Scouts as the Honorable Gerald R. Ford, the
- 5 thirty-eighth president of the United States; Captain James Lovell, the commander of the
- 6 Apollo 13 space flight; Neil Armstrong, the first man to walk on the moon; acclaimed
- 7 filmmaker Steven Spielberg; and Bill Gates, the founder of Microsoft; and
- 8 WHEREAS, the legacy for the Boy Scouts of America is indeed a rich one, for it not
