

HOUSE COMMITTEE AMENDMENTS

2016 Regular Session

Amendments proposed by House Committee on Transportation, Highways, and Public Works to Reengrossed Senate Bill No. 227 by Senator Colomb

1 AMENDMENT NO. 1

2 On page 1, line 2, delete "R.S. 32:410(E)" and insert "R.S. 32:409.1(A)(2)(d)(ix) and 410(E)
3 and (F)"

4 AMENDMENT NO. 2

5 On page 1, line 5, delete "in compliance with the REAL ID Act of 2005" and after the semi-
6 colon ";" insert "to require applicants for either a driver's license or special identification
7 card to provide proof of Louisiana residency;"

8 AMENDMENT NO. 3

9 On page 1, line 6, after "of the REAL ID Act" delete the semi-colon ";" and insert " of 2005;
10 to require certain documents or photographs obtained in the process of applying for a driver's
11 license be retained or purged in certain circumstances;"

12 AMENDMENT NO. 4

13 On page 1, line 9, delete "R.S. 32:410(E) is" and insert "R.S. 32:409.1(A)(2)(d)(ix) and
14 410(E) and (F) are"

15 AMENDMENT NO. 5

16 On page 1, between lines 9 and 10, add the following:

17 "§409.1. Application or special certificate applications; penalties for false
18 information
19 A.

21 (2) An applicant for a driver's license shall provide the following
22 information:

23 * * *

24 **(ix) Proof of Louisiana residency. Proof of residency shall include but**
25 **not be limited to paid receipts for utility bills and bank statements."**

26 AMENDMENT NO. 6

27 On page 2, delete line 12 through 19 in their entirety and on line 20, delete "**January 1,**
28 **2016.**" insert in lieu thereof the following:

29 **"(3) Any person applying for a driver's license pursuant to the**
30 **provisions of this Chapter who elects not to apply for a driver's license**
31 **that complies with REAL ID standards and who is otherwise eligible to**
32 **be issued a driver's license pursuant to the provisions of this Chapter**
33 **shall be issued a driver's license which indicates the driver's license is**
34 **not in compliance with REAL ID. If the person has elected not to apply**
35 **for a REAL ID compliant driver's license, the department shall not**
36 **require the applicant to comply with any REAL ID requirements that**
37 **were not required by the state as of January 1, 2016, or require the**
38 **applicant to submit to a facial image capture in connection with such**

1 application prior to determining if such applicant is eligible to be issued
2 a driver's license pursuant to the provisions of this Chapter."

3 AMENDMENT NO. 7

4 On page 3, delete lines 2 through 7 in their entirety and insert in lieu thereof the following:

5 "(b) The department shall provide each applicant for a driver's license
6 a printed document that includes the following information:

7 (i) The documents that an applicant is required to provide to
8 obtain a REAL ID compliant driver's license, and the documents an
9 applicant is required to provide to obtain a driver's license that is not
10 REAL ID compliant.

11 (ii) The purposes for which a REAL ID compliant driver's license
12 may be utilized, and the purposes for which a driver's license that is not
13 REAL ID compliant may be utilized.

14 (iii) The electronic technology incorporated into a REAL ID
15 compliant driver's license, and the electronic technology incorporated
16 into a driver's license that is not REAL ID compliant."

17 AMENDMENT NO. 8

18 On page 3, line 17, after "issued" insert "such driver's license at the cost of"

19 AMENDMENT NO. 9

20 On page 3, between lines 17 and 18 insert the following:

21 "(7) Upon the request of any applicant for a driver's license, the
22 department shall record and retain the applicant's name, date of birth,
23 certificate numbers, date filed, and issuing agency in lieu of retaining an image
24 or copy of the applicant's birth certificate."

25 AMENDMENT NO. 10

26 On page 3, at the beginning of line 18, change "(7)" to "(8)"

27 AMENDMENT NO. 11

28 On page 3, between lines 22 and 23, insert the following:

29 "F.(1) Upon request of any person, any personal identifying source
30 documents or photographs of such person obtained by the department or a
31 contractor in the process of a person applying for or renewing a driver's license
32 between July 7, 2008, and the effective date of this Subsection that were not
33 required by state law to be captured by the department or a contractor as of
34 July 7, 2008, shall be disposed of as follows:

35 (a) Personal identifying source documents shall be removed and
36 purged from department and contractor databases and systems.

37 (b) All photographs of persons obtained by the department
38 which are in the possession of a contractor shall be purged from the
39 database or system of that contractor.

40 (2) As used in this Subsection, the following terms shall mean and
41 include:

42 (a) "Contractor" shall mean and include any contractor of the
43 department, any affiliate or subsidiary of such contractor, and any
44 subcontractor of such contractor or any affiliate or subsidiary of such
45 subcontractor.

1 **(b) "Personal identifying source documents" shall mean and include**
2 **any document provided by any person to prove his identity or residence. It**
3 **shall include all copies, scans, or digital images of such documents.**

4 **(c) "Photographs" shall mean and include any captured image, digital**
5 **or otherwise, of a person's face. It shall include all copies, scans, or digital**
6 **images of such image."**

7 AMENDMENT NO. 12

8 On page 4, delete lines 18 through 26 in their entirety and on line 27, delete "of January 1,
9 2016." and insert in lieu thereof the following:

10 **"(3) Any person applying for a special identification card pursuant to**
11 **the provisions of this Section who elects not to apply for a special identification**
12 **card that complies with REAL ID standards and who is otherwise eligible to be**
13 **issued a special identification card pursuant to the provisions of this Section**
14 **shall be issued a special identification card which indicates the special**
15 **identification card is not in compliance with REAL ID. If the person has elected**
16 **not to apply for a REAL ID compliant special identification card, the**
17 **department shall not require the applicant to comply with any REAL ID**
18 **requirements that were not required by the state as of January 1, 2016."**

19 AMENDMENT NO. 13

20 On page 5, delete lines 10 through 16 in their entirety, and insert in lieu thereof the
21 following:

22 **"(b) The department shall provide each applicant for a special**
23 **identification card a printed document that includes the following information:**

24 **(i) The documents that are required to be provided by the applicant to**
25 **obtain a REAL ID compliant special identification card, and the documents that**
26 **are required to be provided by the applicant to obtain a special identification**
27 **card that is not REAL ID compliant.**

28 **(ii) The purposes for which a REAL ID compliant special identification**
29 **card may be utilized and the purposes for which a special identification card**
30 **that is not REAL ID compliant may be utilized.**

31 **(iii) The electronic technology incorporated into a REAL ID compliant**
32 **special identification card and the electronic technology incorporated into a**
33 **special identification card that is not REAL ID compliant."**
