 Makes revisions to the La. Election Code

Proposed law makes multiple technical changes to the election code. Proposed law adds a member of the Police Jury Association of Louisiana to the State Board of Election Supervisors. Proposed law changes the quorum of the State Board of Election Supervisors from four members to five members.

Sections 1 & 3 of the proposed law will become effective upon signature of the governor or upon lapse of action by the governor pursuant to Article III, Section 18 of the LA Constitution. Section 2 of the proposed law will become effective on January 1, 2017.

EXPENDITURE EXPLANATION

The proposed legislation has several provisions with associated nominal expenditure increases associated with printing costs, postage costs, and form generation. The Secretary of State anticipates being able to absorb all associated increases within its budget. Furthermore, the Secretary of State reports that adding a member of the Police Jury Association of Louisiana to the State Board of Election Supervisors carries minimal expense as board members do not receive compensation, but are allowed to claim expenses. The Secretary of State anticipates being able to absorb costs associated with the additional board member within its existing budget authority.

REVENUE EXPLANATION

There is no anticipated direct material effect on governmental revenues as a result of this measure.
