Provides relative to student behavior and discipline, including the use of seclusion and physical restraint to address the behavior of students with exceptionalities. (gov sig)

Proposed law creates the Advisory Council on Student Behavior and Discipline to provide advice and guidance to the State Board of Elementary and Secondary Education (BESE) and the state Department of Education (DOE) regarding best practices in the adoption and implementation of school student behavior and discipline plans. The DOE shall provide staff support to the council which shall convene the first meeting not later than September 1, 2016. The council shall meet at least three times annually and shall submit annual reports to the House and Senate Education committees with respect to the school master plan for improving student behavior and discipline. Present law exempts certain discipline practices from the definition of "physical restraint". Proposed law revises exemptions to the definition as well as the threshold for three week review and revision of student intervention plans by the student's Individualized Education Plan team. Requires DOE to annually compile a comprehensive report regarding the use of seclusion and physical restraint of students with exceptionalities including the specified data elements and a list of the school systems and charter schools that have complied with the prescribed reporting requirements.
