Amendments proposed by Senate Committee on Judiciary A to Original Senate Bill No. 120

1 AMENDMENT NO. 1

2 On page 1, at the beginning of line 2, after "To" and before the comma "," delete "enact R.S.
3 13:51" and insert the following:

4 "amend and reenact R.S. 13:2563.5(B) and 2563.17(A) through (C), and to enact
5 R.S. 13:2563.5(C)"

6 AMENDMENT NO. 2

7 On page 1, line 2, after "salaries;" delete the remainder of the line and insert the following:

8 "to provide for the payment of a judge's salary in Ascension Parish; to require the
9 appropriation of amounts sufficient to fully fund the operations of the Parish Court
10 in Ascension Parish; to provide with respect to the disposition of fees deposited into
11 the Ascension Parish Judicial Expense Fund; to provide with respect to authority of
12 the judge of the Ascension Parish Court with regard to the Ascension Parish Judicial
13 Expense Fund;"

14 AMENDMENT NO. 3

15 On page 1, delete line 3

16 AMENDMENT NO. 4

17 On page 1, line 4, at the beginning of the line, delete "Commission;"

18 AMENDMENT NO. 5

19 On page 1, line 6, after "Section 1." delete the remainder of the line and insert the following:

20 "R.S. 13:2563.5(B) and 2563.17(A) through (C) are hereby amended and reenacted
21 and R.S. 13:2563.5(C) is hereby enacted to read as follows:

22 §2563.5. Judge; qualifications and salary

23 * * *

24 B. He shall receive an annual salary of not less than sixty-eight thousand five
25 hundred twenty-two dollars, payable monthly on his own warrant by the state of
26 Louisiana, the parish of Ascension, the municipalities within the parish of Ascension,
27 and the judicial expense fund for the Parish Court for the Parish of Ascension,
28 apportioned as follows:

29 (1) The state of Louisiana shall pay the sum of forty-four thousand two
30 hundred sixty-five dollars per annum, **subject to the increases mandated by R.S.**
31 **13:50.**

32 (2) ~~The parish of Ascension shall pay the sum of seven thousand one~~
33 ~~hundred ten dollars per annum.~~

34 (3) The municipalities of Donaldsonville and Gonzales shall each pay the
35 sum of seven thousand one hundred ten dollars per annum.

36 (4)(3) Any other municipality within the parish of Ascension shall each pay
37 the sum of two thousand nine hundred twenty-seven dollars per annum.
