20 **of Governmental Ethics, R.S. 42:1101 et seq.**

21 **B. The board, in its capacity as the governing body of the authority,**
22 **shall ensure that the books and records of the authority are audited by the**
23 **legislative auditor in accordance with the provisions of R.S. 24:513."**

32 donation, devise₂ or other legal means, in trust or absolutely, real or personal
33 property, whether tangible or intangible, subject to the terms, conditions₂ or
34 limitations contained in the instrument by which such property is acquired. The
35 authority is hereby specifically empowered to serve as the beneficiary of a public

1 trust heretofore or hereafter created pursuant to **the provisions of** R.S. 9:2341 to
 2 **through** 2347 ~~as now or hereafter amended~~. The authority may also accept and
 3 expend any sum appropriated by the federal government, the state of Louisiana, or
 4 any political subdivision or agency thereof for the purpose of administering ~~this Act~~
 5 **the provisions of this Chapter** or for the carrying out of any purposes or functions
 6 of the authority authorized ~~thereby~~ **in this Chapter**.

8 (7) To own, hold, sell, mortgage, convey, lease, rent, alienate, and otherwise
 9 manage, contract with reference to, or dispose of, all or any part of its property, real
 10 or personal, or services, on any terms and conditions as may be lawful and consistent
 11 with the provisions and objectives of this ~~Act~~ **Chapter**, and likewise to invest all
 12 proceeds and income of such property in any type or kind of property, real or
 13 personal, tangible or intangible, as appears advisable to the board; provided that the
 14 authority shall not lease any facility acquired for demolition, including individual
 15 rooms or apartments or housing accommodations acquired for such purpose, for
 16 longer than a period of one year at a time.
