2 On page 2, line 30, after "diet" delete the remainder of the line and insert a "." and on page
3 3, delete lines 1 through 3

4 AMENDMENT NO. 12

5 On page 3, delete lines 4 through 9 in their entirety and insert in lieu thereof the following:

6 "BE IT FURTHER RESOLVED that no later than sixty days prior to the convening
7 of the 2017 Regular Session of the Legislature of Louisiana the Department of Health and
8 Hospitals shall develop and submit to the House Committee on Health and Welfare and the
9 Senate Committee on Health and Welfare a report pursuant to the study effort called for in
10 this Resolution which, at minimum, addresses all of the following:

11 (1) The feasibility and desirability of the prospective program detailed in this
12 Resolution.

13 (2) Data on the costs to the public health systems of this state attributable to chronic
14 health conditions among the SNAP target population addressed in this Resolution that are
15 significantly impacted by diet.

16 (3) Data on the impact to health outcomes of improvements in diet among SNAP
17 recipients with chronic health conditions that are significantly impacted by diet.

18 (4) Data on cost savings to public health systems attributable to improvements in
19 diet among the SNAP target population addressed in this Resolution, or best estimates of
20 such cost savings if actual data is not available."
