Amends provisions of law regarding domestic abuse battery

Proposed law amends and reenacts certain sections of law relative to domestic abuse battery; to require completion of a court-monitored domestic abuse intervention program as a part of the sentence for conviction of domestic abuse battery; and to provide for related matters.
