Purpose of the Bill: This measure provides that the cost and charges related to the 19th Judicial District Court (JDC) Judicial Building Fund now apply to cases involving juvenile matters.

Act No. 202 of the 2003 Regular Session requires that any new court cost or fee or increase in an existing court cost or fee must first be submitted to the Judicial Council for review and recommendation. Per a review of the 2016 Report of the Judicial Council, there was no application for consideration of the proposed increase in the cost for fees in the Juvenile Court.

REVENUE EXPLANATION

This measure may increase local government revenues for the 19th JDC Judicial Building Fund by \$45,800 annually.

This measure removes the exemption in current law for juvenile matters relating to the costs and charges imposed by RS 13:992.1(B). An official with the Juvenile Court of East Baton Rouge Parish provided that this measure will increase fees by \$45,800 annually.
