2 On page 3, at the end of line 23, insert "selected as follows, **subject to the requirements**
3 **of Subsection C of this Section relative to overall composition of the board:**"

7 On page 3, delete lines 24 through 26 in their entirety

9 On page 4, delete lines 18 and 19 in their entirety and insert in lieu thereof the following:

10 **"(1) One member shall be appointed by the governor from a list of three**
11 **names submitted by the chancellor of the Louisiana State University Health**
12 **Sciences Center at New Orleans.**

13 **(2) One member shall be appointed by the governor from a list of three**
14 **names submitted by the chancellor of the Louisiana State University Health**
15 **Sciences Center at Shreveport.**

16 **(3) One member shall be appointed by the governor from a list of three**
17 **names submitted by the president and chief executive officer of Tulane Health**
18 **System.**

19 **(4) One member with broadly recognized expertise and experience in the**
20 **development of healthcare facilities and related infrastructure appointed by the**
21 **governor.**

22 **(5) One member with broadly recognized expertise and experience in the**
23 **financing of healthcare facilities and related infrastructure appointed by the**
24 **governor.**

25 **(6) One member with broadly recognized expertise and experience as an**
26 **advocate for medically underserved populations in Louisiana appointed by the**
27 **governor.**

28 **(7) One member with broadly recognized expertise and experience as a**
29 **healthcare professional who lives and works in a small city, town, or village or**
30 **in a rural community appointed by the governor.**

31 ~~(7) Three~~ **(8) Two** members shall be appointed by the governor from the
32 state at large.

33 **C.(1) The board shall be comprised of at least one member from each**
34 **of the five public service commission districts of the state as established in R.S.**
35 **45:1161.5.**

36 **(2) No public service commission district shall be represented by more**
37 **than two members of the board.**
