## **EXPENDITURE EXPLANATION**

<u>Proposed concurrent resolution</u> is not anticipated to create a direct material effect on governmental expenditures. <u>Proposed concurrent resolution</u> urges and requests each department of the executive branch of state government to submit to the commissioner of administration, the legislature and the Task Force on Structural Changes in Budget and Tax Policy by July 1, 2016, a report that outlines the initiatives the department will take to ensure a more efficient operation for FY 17 and beyond.

While the requirement to produce a report outlining initiatives for more efficient operations will result in a workload increase, the LFO feels any such work will be nominal and not likely different than the variety of numerous reports state agencies are asked to produce on a regular basis as part of normal operations. The Commissioner of Administration has met with executive branch agencies on multiple occasions since December of 2015 to discuss fiscal and efficiency options and to formulate plans for addressing these matters. The Division of Administration reports that any workload increase resultant of proposed concurrent resolution cannot be determined and is wholly dependent upon the total initiatives adopted by all executive branch agencies and any potential strategies to produce more efficient operations that may be derived thereof.

There is no anticipated direct material effect on governmental revenues as a result of this measure.
